**CITY RESOLUTION NO. 261-08-2020**

**RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN AND AMONG THE CITY GOVERNMENT OF TUGUEGARAO, SECURITY BANK FOUNDATION, INC. (SBFI), SECURITY BANK CORPORATION, ATENEO DE MANILA UNIVERSITY (ADMU) AND DEPARTMENT OF EDUCATION DIVISION OF TUGUEGARAO CITY FOR THE “BUILD A SCHOOL, BUILD A NATION: THE CLASSROOMS PROJECT” AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN AND CONCUR FOR AND ON BEHALF OF THE CITY GOVERNMENT OF TUGUEGARAO THE SAID MOA**

**WHEREAS**, Article 14, Section 1 of the Philippine Constitution provides that the “*State shall protect and promote the right of all citizens to quality education at all levels of education and shall take appropriate steps to make such education accessible to all*”

**WHEREAS**, pursuant to the herein provision, it is the goal of the City Government of Tuguegarao and all other concerned government and non-government agencies and organizations to work hand in hand in order to continuously improve the system of education and make it be accessible to everyone;

**WHEREAS**, to realize the said goal, the City Government of Tuguegarao shall partner with Security Bank Foundation and Ateneo De Manila University for their “*Build a School, Build a Nation: The Classrooms Project*”;

**WHEREAS**, for the above purpose, there shall be a Memorandum of Agreement (MOA) between and among the City Government of Tuguegarao, Security Bank Foundation, Inc., Security Bank Corporation, Ateneo De Manila University and Department of Education Division of Tuguegarao City;

**WHEREAS**, the chosen school beneficiary for the said project in Tuguegarao City is the Tuguegarao West Central School;

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, indorsed to the Eighth City Council the said MOA and requested for an authority to sign for and on behalf of the Tuguegarao City Government the said MOA;


**WHEREAS**, the Eighth City Council during its 66<sup>th</sup> Regular Session held on December 3, 2020 found the terms and conditions of the Memorandum of Agreement to be in order, with merit and beneficial to the constituents of the City;

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement (MOA) Between and Among the City Government of Tuguegarao, Security Bank Foundation, Inc. (SBFI), Security Bank Corporation, Ateneo de Manila University (AdMU) and Department of Education Division of Tuguegarao City for the "*Build A School, Build A Nation: The Classrooms Project*" and Granting Authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign and concur for and on behalf of the City Government of Tuguegarao the said MOA.
