CITY RESOLUTION NO. 267-08-2020

RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE EASYPAY GLOBAL EMI CORPORATION AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA

WHEREAS, the referral *“Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with EASYPAY EMI Corp.”* was endorsed to the Eighth City Council;

WHEREAS, the Committee on Rules, Laws and Ethics and Committee on Trade, Commerce and Industry, to which the matter was referred to, initially met on October 29, 2020 and finally met on November 24, 2020 to discuss the subject referral with the presence of resource persons;

WHEREAS, the Committees passed Committee Report No. 101-2020 recommending the conduct of a dry-run in the Executive and Legislative Department;

WHEREAS, Committee Report No. 101-2020 was approved and adopted during the Regular Session held on November 05, 2020;

WHEREAS, the dry run was conducted on November 24, 2020 which was facilitated by the Office of the City Mayor;

WHEREAS, the Joint Committees recommended for the adoption and approval of the Memorandum of Agreement and granting authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement, subject to the suggestions of the committee as contained in Committee Report No. 101-2020 as amended and that it is not exclusive in nature and character.


