RESOLUTION EARNESTLY REQUESTING FROM THE OFFICE OF SECRETARY WILLIAM DAR THROUGH THE DEPARTMENT OF AGRICULTURE REGION 02 FOR AGRICULTURAL (LIVESTOCK) REPLENISHMENT ASSISTANCE TO LOCAL FARMERS AFFECTED BY TYPHOONS AND MASSIVE FLOODING IN TUGUEGARAO CITY

WHEREAS, Region 02 is one of the Rice Producers in the Philippines while Tuguegarao City is considered one of the twenty-five (25) most outstanding Corn producers in the Philippines based from Department of Agriculture (DA) Production data;

WHEREAS, President Rodrigo R. Duterte has issued Proclamation No. 1051 placing the entire Luzon under the state of calamity due to the effects of typhoons Quinta, Siony and Ulysses;

WHEREAS, on November 9, 2020, Magat Dam started to release volumes of water as a precautionary measure to prevent damage to the Dam;

WHEREAS, as early as November 12, 2020, the National Irrigation Administration (NIA) opened Seven (7) irrigation gates of Magat Dam and unleashed more than Six Thousand (6,000) cubic meter per second from the stockpiled water due to the increased water level in the said Dam;

WHEREAS, DENR Secretary and Calamity Rehabilitation TZAR Roy Cimatu has pronounced that Tuguegarao City Cagayan is flood prone area and catch basin in the Northeastern Philippines;

WHEREAS, typhoons Quinta, Siony and Ulysses caused a massive flooding with Ninety (90%) Percent of Tuguegarao Land Area submerged by water;

WHEREAS, Corn and rice fields were submerged by water because of recurrent floodings brought by successive typhoons aggravated by northeast monsoon rains resulting to the loss of livestocks, poultry and similar agricultural products;

WHEREAS, attached herewith and shall form of the resolution are the necessary reports and documents in relation with agricultural damages and various stated programs of the Department of Agriculture (DA) submitted for reference by Dr. Evangeline P. Calubaquib, City Agriculturist, and Dr. Pastor C. Tumaliuan Jr, City Veterinarian;

WHEREAS, agricultural crops such as corn and rice are already covered with various agricultural production support programs abovementioned, hence, the livestock sector must also be prioritized for agricultural replenishment assistance;

WHEREAS, the Committee on Agriculture and Food, Market and Livestock Auction Center met on November 26, 2020 to deliberate on "Resolution Earnestly Requesting from the Office of Secretary William Dar through the Department of Agriculture-Region 02 for Agricultural Replenishment Assistance to Local Farmers Affected by Typhoons and Massive Flooding in Tuguegarao City- sponsored by Hon. Gilbert S. Labang et al."


WHEREAS, the committee finds the subject matter to be meritorious and beneficial especially to the farmers in Tuguegarao City.
