CITY RESOLUTION NO. 284-08-2020

A RESOLUTION ADOPTING AND APPROVING LOCAL SCHOOL BOARD RESOLUTION NO. 19-2020 TITLED “A RESOLUTION SUPPORTING AND STRONGLY RECOMMENDING TO THE 8th CITY COUNCIL THE SEPARATION OF THE SENIOR HIGH SCHOOL FROM THE CAGAYAN NATIONAL HIGH SCHOOL TO BE NAMED AS CAGAYAN NATIONAL HIGH SCHOOL SENIOR HIGH”

WHEREAS, Sections 1 and 2 of Article XIV of the 1987 Philippine Constitution mandate that the state shall protect and promote the right of all citizens to quality education at all levels, take the appropriate steps to make such education accessible to all and establish, maintain and support a complete, adequate, and integrated system of education relevant to the needs of the people and the society;

WHEREAS, Section 3 of Republic Act No. 9155, otherwise known as the “Governance of Basic Education Act of 2001,” states that one of the said act’s objectives is to establish schools where schoolchildren are able to learn a range of core competencies prescribed for elementary and high school education programs;

WHEREAS, Department of Education Order No. 51, series of 2015 provides the guidelines on the implementation of the Senior High School (SHS) Program in existing public Junior High Schools (JHSs) and Integrated Schools (ISs), establishment of stand-alone public SHSs and conversion for existing public elementary and JHSs into stand-alone SHSs;

WHEREAS, in 2015, the Tuguegarao City Schools Division Office introduced the Senior High School Program at the Cagayan National High School and offered all the SHS tracks;

WHEREAS, Local School Board Resolution No. 19-2020 titled “A resolution supporting and strongly recommending to the 8th City Council the separation of the Senior High School form the Cagayan National High School to be named as Cagayan National High School Senior High” was endorsed by the City Mayor, Hon. Atty. Jefferson P. Soriano, to the Eighth City Council;

WHEREAS, the Eighth City Council during its 68th Regular Session held on December 22, 2020 found the matter to be in order, with merit and beneficial to the constituents of the City;



RESOLVED FURTHER, to furnish a copy of this Resolution to the Department of Education and Division Office of Tuguegarao for information.


On joint motion, **CITY RESOLUTION NO. 284-08-2020** was **UNANIMOUSLY APPROVED** under suspended rules.
