**CITY RESOLUTION NO. 285-08-2020**

**RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH – CAGAYAN VALLEY CENTER FOR HEALTH AND DEVELOPMENT ON THE TRANSFER OF FUNDS PURSUANT TO ADMINISTRATIVE ORDER NOS. 35 AND 36 AUTHORIZING THE GRANT OF ACTIVE HAZARD DUTY PAY (AHDP) AND COVID-19 SPECIAL RISK ALLOWANCE (SRA) TO ELIGIBLE HEALTH WORKERS AND TO GRANT AUTHORITY TO THE CITY MAYOR, HON. ATTY JEFFERSON P. SORIANO TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT TO SIGN THE SAID MOA**

**WHEREAS**, Proclamation No. 922, series of 2020 declared a State of Public Health Emergency in recognition of the COVID-19 public health event as threat to national security, and prompted a whole-of-government approach in addressing the COVID-19 outbreak in the country;

**WHEREAS**, Republic Act (RA) 11494, known as “Bayanihan to Recover as One Act”, affirmed the existence of a continuing national emergency in view of the unabated spread of COVID-19 and the economic disruption ensuing from it;

**WHEREAS**, pursuant to Section 4(w) of RA 11494, Administrative Order No. 35 was issued by the Office of the President authorizing the grant of active hazard duty pay (AHDP) to Human Resources for Health (HRHs) serving in the frontlines during the state of national emergency;

**WHEREAS**, pursuant to Section 4(h) of the same Act, Administrative Order No. 36 was issued by the Office of the President authorizing COVID-19 Special Risk Allowance (SRA) to private and public health workers directly catering to or in contact with COVID-19 patients during the state of national emergency;

**WHEREAS**, the Department of Health (DOH) and the Department of Budget and Management (DBM) issued Joint Circular (JC) Nos. 1 and 2, both series of 2020 dated November 25, 2020, providing the guidelines on the grant of AHDP and COVID-19 SRA to eligible health workers, respectively;

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, indorsed to the Eighth City Council the said MOA and requested for an authority to sign for and on behalf of the Tuguegarao City Government the said MOA;

**WHEREAS**, the Eighth City Council during its 68<sup>th</sup> Regular Session held on December 22, 2020 found the terms and conditions of the Memorandum of Agreement to be in order, with merit and beneficial to the constituents of the City;

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement with the Department of Health – Cagayan Valley Center for Health and Development on the transfer of funds pursuant to Administrative Order Nos. 35 and 36 authorizing the grant of Active Hazard Duty Pay (AHDP) and COVID-19 Special Risk Allowance to eligible health workers and to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano to sign for and on behalf of the Tuguegarao City Government to sign the said MOA.

**RESOLVED FURTHER**, to furnish a copy of this Resolution to the Department of Health – Cagayan Valley Center for Health and Development for information and action.
