RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE FOR THE IMPLEMENTATION OF ENHANCED KADIWA INCLUSIVE FOOD SUPPLY CHAIN PROGRAM AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA

WHEREAS, the Department of Agriculture is mandated to promote agricultural development by providing policy framework, public investments and support services needed for domestic and exportoriented business enterprises;

WHEREAS, the Department of Agriculture has launched the Enhanced Kadiwa Inclusive Food Supply Chain Program to ensure food availability and accessibility during the COVID-19 pandemic and beyond;

WHEREAS, under the program, the Department of Agriculture provides financial grant assistance to participating eligible organizations and local government units (LGUs) to enhance their capacities in value-adding activities in the food supply chain from aggregation, processing, packing, storing, warehousing, transport to distribution;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, indorsed to the Eighth City Council the said MOA and requested for an authority to sign for and on behalf of the Tuguegarao City Government the said MOA;

WHEREAS, the Eighth City Council during its 68th Regular Session held on December 22, 2020 found the terms and conditions of the Memorandum of Agreement to be in order, with merit and beneficial to the constituents of the City;
