CITY RESOLUTION NO. 289-08-2020

RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS TO SUSPEND THE IMPLEMENTATION OF ALL DRAINAGE PROJECTS IN TUGUEGARAO CITY

WHEREAS, Chapter III on Intergovernmental Relation, Article I, Section 25(b) of the Local Government Code states that "National agencies and offices with project implementation functions shall coordinate with one another and with the local government units concerned in the discharge of these functions. They shall ensure the participation of local government units both in the planning and implementation of said national projects";

WHEREAS, the City Government is in the process of coming up with a Comprehensive Drainage Master Plan for the entire city in order to prevent flash floods whenever a heavy downpour occurs;

WHEREAS, this Plan will include a River Embarkment Protection Plan along the Cagayan River Bank in order to prevent the overflow of the river, backflow and clogging of drainage outlets;

WHEREAS, it was also included in the Plan a Water Treatment System before the water is released to the river outlets;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, wrote DPWH Regional Director, Engr. Loreta M. Malalauan, to reiterate the request for the suspension of the implementation of all drainage projects in the city except those undertaken at Gunnacao Street, Cataggaman Nuevo and San Jose-Bagay Road at Barangays Atulayan Sur and Bagay until the completion of the Comprehensive Drainage Master Plan;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, indorsed to the Eighth City Council the request for the passage of a resolution requesting the DPWH to suspend implementation of all drainage projects except those cited above;

WHEREAS, the Eighth City Council during its 68th Regular Session held on December 22, 2020 found the request to be in order, with merit and beneficial to the constituents of the City.

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to approve the request for the passage of a resolution requesting the Department of Public Works and Highways to suspend the implementation of all drainage projects in Tuguegarao City except those undertaken at Gunnacao Street, Cataggaman Nuevo and San Jose-Bagay Road at Barangays Atulayan Sur and Bagay until the completion of the Comprehensive Drainage Master Plan.

RESOLVED FURTHER, to furnish a copy of this Resolution to the Department of Public Works and Highways for information and action.
