APPROPRIATION ORDINANCE NO. 02-08-2021

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 02 OF **TUGUEGARAO CITY FOR 2021 FOR FY 2017 AND FY 2018 EXCISE TAX UTILIZATION**

WHEREAS, Section 458 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and Article 99 (2)(i) of the Rules and Regulations Implementing the Local Government Code of 1991 provide that the Sangguniang Panlungsod has the power to "approve annual and supplemental budgets of the City Government and appropriate funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law, in order to promote the general welfare of the city and its inhabitants;"

WHEREAS, Local Budget Memorandum (LBM) Circular No. 81 dated November 4, 2020 provides the guidelines on the Release and Utilization of the Shares of Local Government Units from FY 2017 Collections of Excise Tax;

WHEREAS, Local Budget Memorandum (LBM) Circular No. 82 dated November 5, 2020 provides the guidelines on the Release and Utilization of the Shares of Local Government Units from FY 2018 Collections of Excise Tax:

WHEREAS, Annex B of LBM No. 81 Shares of Cities and Municipalities from CY 2017 Collection of Burley and Native Tobacco Excise under RA 8240 as amended by RA. 1035 includes Tuguegarao City with a Total Share of Five Million One Hundred Seventy-One Thousand Six Hundred Eighty Pesos (P5,171, 680.00);

WHEREAS, Section 2.10 of LBM Circular No. 81 dated November 4, 2020 states that "the shares of the beneficiary LGUs shall be treated as a Special Account under the General Fund of the LGUs to be utilized for the programs and projects enumerated under item 3.0 hereof;"

- WHEREAS, Annex B of LBM No. 82 on Shares of Cities and Municipalities from CY 2018 Collection of Burley and Native Tobacco Excise under RA 8240 as amended by R.A. 10351 includes Tuguegarao City with a Total Share of Seventeen Million Nine Hundred Twenty-Nine Thousand Six Hundred Twelve Pesos (Php17,929,612.00);
- WHEREAS, Section 2.4 of LBM Circular No. 82 dated November 5, 2020 on Treatment of Shares of LGUs states that "the shares of the beneficiary LGUs from tobacco excise taxes shall be treated as a Special Account under the General Fund of the LGUs to be utilized exclusively for programs and projects pursuant to Section 2 of R.A. 7171 and Section 8 of R.A. 8240 as amended by Section 8 of R.A. No. 10351;"
- WHEREAS, the Tuguegarao Tobacco Producers Cooperative has approved the list of programs and projects to be funded under the Excise Tax FY 2017 as per Board Resolution No. 16-2021;
- WHEREAS, the Tuguegarao Tobacco Producers Cooperative has approved the list of programs and projects to be funded under the Excise Tax FY 2018 as per Board Resolution No. 16-A-2021;
- WHEREAS, City Development Council (CDC) Resolution No. 09-2021 titled "Resolution Endorsing to the Eighth Tuguegarao City Council the Amendment of CDP CY 2019-2025, ELA and LDIP CY 2019-2022 and ADP CY 2021 to Include the Construction of Cooperative Multi-Purpose Building" was adopted and approved through City Resolution No. 145-08-2021 by the Eighth City Council during its 80th Regular Session held on March 23, 2021;
- WHEREAS, City Development Council (CDC) Resolution No. 07-2021 titled "Resolution Endorsing to the Eighth Tuguegarao City Council the Approval of Supplemental Investment Program CY 2021 for FY 2017 Collections and Excise Tax" and City Development Council (CDC) Resolution No. 10-2021 titled "Resolution Endorsing to the Eighth Tuguegarao City Council the Approval of the Supplemental Annual Investment Program for CY 2021 for FY 2018 Excise Tax Utilization" were adopted and approved through City Resolution No. 146-08-2021 by the Eighth City Council during its 80th Regular Session held on March 23, 2021;
- WHEREAS, City Development Council (CDC) Resolution No. 08-2021 titled "Resolution Endorsing to the Eighth Tuguegarao City Council the Approval of FY 2017 Excise Tax Utilization" and City Development Council (CDC) Resolution No. 11-2021 titled "Resolution Endorsing to the Eighth Tuguegarao City Council the Approval of the FY 2018 Excise Tax Utilization" were adopted and approved through City Resolution No. 147-08-2021 by the Eighth City Council during its 80th Regular Session held on March 23, 2021;
- WHEREAS, the Appropriation Ordinance Authorizing Supplemental Budget No. 02 for CY 2021 in the amount of Twenty-Three Million One Hundred One Thousand Two Hundred Ninety-Two Pesos (P23,101,292.00) to fund programs and projects as contained in CDC Resolution Nos. 07 and 10, series of 2021 was enacted by the Eighth City Council in plenary;
- WHEREAS, Supplemental Budget No. 02 of Tuguegarao City for CY 2021 has fully complied with the budgetary requirements and general limitations as provided by RA No. 7160, otherwise known as the Local Government Code of 1991, and other laws.
- NOW, THEREFORE, be it ORDAINED by the Eighth City Council in session assembled, to enact:
- **SECTION 1. AUTHORIZATION**. Supplemental Budget No. 02 of Tuguegarao City for CY 2021 with a total appropriation of Twenty-Three Million One Hundred One Thousand Two Hundred Ninety-Two Pesos (P23,101,292.00) is authorized to finance the Programs and Projects of Share from Excise Tax FY 2017.
- **SECTION 2. SOURCE OF APPROPRIATION**. The Appropriation shall be sourced out from the Shares from Excise Tax FY 2017 and 2018 amounting to Twenty-Three Million One Hundred One Thousand Two Hundred Ninety-Two Pesos (P23,101,292.00):

SECTION 5. SEPARABILITY CLAUSE. If for any reason that any section or provision of this ordinance is declared unconstitutional or contrary to other laws and statutes, other sections or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 6. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.
