



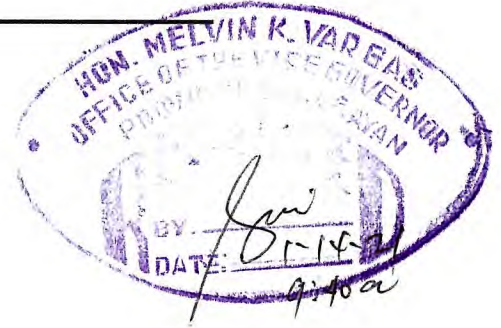


**Madam:**

**CITY ORDINANCE NO. 01-08-2021**

**AN ORDINANCE SUSPENDING THE IMPLEMENTATION OF CITY ORDINANCE NO. 01-08-2020 TITLED “AN ORDINANCE AMENDING CITY ORDINANCE NO. 07-2011 ENACTING THE REVENUE CODE OF TUGUEGARAO CITY” PARTICULARLY SECTION 2.A.08 ON ADMINISTRATIVE PROVISION, SUBSECTION 18(C) ON ASSESSMENT LEVELS”**

**WHEREAS**, City Ordinance No. 01-08-2020 titled “An Ordinance Amending City Ordinance No. 07-2011 Titled “An Ordinance Enacting the Revenue Code of Tuguegarao City” Particularly Section 2.A.08 on Administrative Provision, Subsection 18(c) on Assessment Levels” was enacted and approved on January 06, 2020;

**WHEREAS**, said Ordinance upgraded the assessment levels of all types of real properties in the City;

**WHEREAS**, the effectivity of the said Ordinance is January 1, 2021;

**WHEREAS**, said Ordinance cannot be implemented as scheduled due to fortuitous events that have transpired during the Year 2020 which impeded the adjustment of the fair market values of real properties;

**WHEREAS**, the revision is still ongoing and will still be subjected to review and refinement before its final approval and implementation.

**NOW, THEREFORE**, be it **ORDAINED** by the Eighth City Council in session assembled, to **ENACT**:

**Section 1. Subject of Suspension.** City Ordinance No. 01-08-2020 is hereby suspended until such time that the revised fair market value of properties is finalized.


**Section 2. Separability Clause.** If, for any reason, a part of this Ordinance is declared illegal or invalid, other parts or provisions hereof which are not affected thereby shall remain valid and in full force and effect.

**Section 3. Repealing Clause.** Any provision of law or regulation inconsistent herewith is hereby repealed, revoked or modified accordingly.


**Section 4. Effectivity.** This ordinance shall take effect immediately upon approval.
