CITY ORDINANCE NO. 06-08-2021

AN ORDINANCE PLACING TUGUEGARAO CITY UNDER GENERAL COMMUNITY QUARANTINE (GCQ) FOR SEVEN (7) DAYS, STARTING FROM 12:01 AM OF FEBRUARY 04, 2021 (THURSDAY) UNTIL MIDNIGHT OF FEBRUARY 10, 2021 (WEDNESDAY) PURSUANT TO EXECUTIVE ORDER NO. 18-2021, AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF

WHEREAS, Section 15, Article II of the 1987 Philippine Constitution provides that it is the State's policy to protect and promote the right to health of the people;


WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that "the Local Government Units are authorized to exercise powers necessary, appropriate or incidental for their efficient and effective governance and those which are essential to the promotion of general welfare";

WHEREAS, the World Health Organization has declared Corona Virus Disease (COVID-19) as a pandemic and in response thereto, President Rodrigo R. Duterte through Proclamation No. 922 declared the Philippines under State of Public Health Emergency;

WHEREAS, Tuguegarao City was placed under Enhanced Community Quarantine for 15 days, from January 20, 2021 to February 3, 2021, due to the increase of COVID-19 cases;

WHEREAS, as of press time, the city recorded a total number of one hundred eleven (111) recoveries, seventy-four (74) of them in just one day and is expecting to have one hundred thirty recoveries in the next 6 days or until February 8, 2021;

WHEREAS, due to the significant improvement, the city government believes that there is no need to prolong the implementation of Enhanced Community Quarantine (ECQ);



WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, wrote a letter dated February 2, 2021, seeking for the approval and concurrence of Governor Manuel N. Mamba and Cagayan Valley Inter-Agency Task Force (CV-RIATF) for the changing of the quarantine status of Tuguegarao City from Enhanced Community Quarantine (ECQ) to General Community Quarantine (GCQ) for a period of seven (7) days;

WHEREAS, this Ordinance shall be upon the concurrence of the Cagayan Valley-Regional Inter-Agency Task Force.

NOW, THEREFORE, be it ORDAINED by the Sangguniang Panlungsod in session assembled, to enact:

Section 1. Title. This Ordinance shall be known as "An Ordinance Placing Tuguegarao City under General Community Quarantine (GCQ) for Seven (7) Days, starting from 12:01 AM February 4, 2021 (Thursday) until Midnight of February 10, 2021 (Friday), pursuant to Executive Order No. 18-2021, and Providing Penalties for Violations Thereof."

Section 2. Subject. Implementation of Executive Order No. 18-2021 dated February 02, 2021 titled "An Order Placing Tuguegarao City under General Community Quarantine (GCQ) for Seven (7) Days and Setting Guidelines Thereof" and RIATF Guidelines, subject to the following:

A. Single Motorcycles

Single motorcycles with a back rider are allowed provided that the back rider will be ferried to and from a workplace especially frontliners and both the driver and the back rider live in the same household as certified by the concerned Barangay (Barangay Certification)

B. Tricycles

a. Private tricycles

- > are allowed to ferry members of the same household from the place of residence to the workplace (vice versa) only.
- > a Barangay Certification must be secured, certifying that the passenger and the driver are members of the same household.
- They must register their private tricycles at the Tricycle and Regulation Unit (TRU) through the TRU Hotline at +639055706809 for smooth control, management and supervision.

b. Tricycles with existing franchise

> are prohibited to be used as private service

C. Talipapas

> Allowing talipapas to operate from Monday to Friday

Section 3. Penalties. For violations of Executive Order No. 18-2021 and/or this Ordinance, the following penalties shall be imposed:

A. Mass Gathering

First Offense: A fine of Two Thousand Pesos (P2,000.00) Second Offense: A fine of Three Thousand Pesos (P3,000.00) Third Offense: A fine of Five Thousand Pesos (P5,000.00)

B. COVID Shield Control Pass (including illegal reproduction thereof)

First Offense: A fine of Five Hundred Pesos (P500.00) Second Offense: A fine of One Thousand Pesos (P1,000.00)

Third Offense: A fine of One Thousand Five Hundred Pesos (P1,500.00) and/or 30 days of

imprisonment upon the discretion of the court





C. Curfew

First Offense: A fine of Two Thousand Pesos (P2,000.00) Second Offense: A fine of Three Thousand Pesos (P3,000.00)

Third Offense: A fine of Five Thousand Pesos (P5,000.00) and/or 30 days of

imprisonment upon the discretion of the court

D. Any other provisions

First Offense: A fine of Two Thousand Pesos (P2,000.00)

Second Offense: A fine of Three Thousand Pesos (P3,000.00) and in case of business

establishments, closure of said establishments.

Third Offense: A fine of Five Thousand Pesos (P5,000.00) and/or 10 days of

imprisonment upon the discretion of the court.

E. For establishments violating any of the provisions of Executive Order No. 18-2021 and/or this Ordinance

First Offense: A Fine of Three Thousand Pesos (P3,000.00) Second Offense: A Fine of Five Thousand Pesos (P5,000.00) Third Offense: Closure of said business establishments

Section 4. All health and safety protocols during the General Community Quarantine (GCQ) promulgated/ordained by the National and Regional Inter-Agency Task Force, the Office of the City Mayor and all ordinances/resolutions approved by the Eighth City Council shall form part of this Ordinance.

Section 5. Public Hearing. This ordinance is enacted under unusual and extreme condition the country is experiencing in general and Tuguegarao City in particular as declared by the National Government through a number of proclamation orders and other rules and regulations promulgated by His Excellency President Rodrigo Duterte and the Provincial Government, hence, the public hearing shall be dispensed with, considering further the urgency and importance of the instant measure.

Section 6. Dissemination. Copies of this ordinance shall be posted in conspicuous places in the city and the City Information Office is directed to cause its massive and widest dissemination.

Section 7. Separability Clause. If any part or provision of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall remain in full force and effect.

Section 8. Repealing Clause. City Ordinances and administrative regulations or part/s thereof which are inconsistent with any provisions of this ordinance are hereby repealed, amended or modified accordingly.

Section 9. Effectivity Clause. This ordinance shall take effect for seven (7) days, from 12:01 AM February 4, 2021 (Thursday) until Midnight of February 10, 2021 (Friday) and shall have no more effect after the lapse of February 10, 2021.
