CITY ORDINANCE NO. 10-08-2021

AN ORDINANCE SETTING GUIDELINES FOR THE IMPLEMENTATION OF MODIFIED GENERAL COMMUNITY QUARANTINE IN TUGUEGARAO CITY PURSUANT TO EXECUTIVE ORDER NO. 21-2021 AND PROVIDING PENALTIES THEREOF

WHEREAS, Section 15, Article II of the 1987 Philippine Constitution provides that it is the State’s policy to protect and promote the right to health of the people;

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that “local government units are authorized to exercise powers necessary, appropriate or incidental for their efficient and effective governance and those which are essential to the promotion of general welfare”;

WHEREAS, the World Health Organization has declared Corona Virus Disease (COVID-19) as a pandemic and in response thereto, President Rodrigo R. Duterte through Proclamation No. 922 declared the Philippines under State of Public Health Emergency;

WHEREAS, Tuguegarao City was placed under Enhanced Community Quarantine from January 20, 2021 to February 3, 2021 and General Community Quarantine from February 04, 2021 to February 10, 2021 considering the number of Covid-19 cases;

WHEREAS, starting February 11, 2021, Tuguegarao City shall be back to Modified General Community Quarantine;

WHEREAS, the Office of the City Mayor has issued Executive Order No. 21-2021 setting guidelines for the implementation of Modified General Community Quarantine;

NOW, THEREFORE, be it **ORDAINED** by the Sangguniang Panlungsod in session assembled, to enact:

Section 1. Title. This Ordinance shall be known as *“An Ordinance Setting Guidelines for the Implementation of Modified General Community Quarantine in Tuguegarao City Pursuant to Executive Order No. 21-2021 and Providing Penalties Thereof.”*

Section 2. Subject. Implementation of Executive Order No. 21-2021 dated February 10, 2021 titled *“An Order Placing Tuguegarao City under Modified General Community Quarantine (MGCQ) and Setting Guidelines Thereof”* and RIATF Guidelines, subject to the following:

- A. Operation of Tricycles. Plate number ending scheme shall be as follows:
 - 1. Tricycles with Plate Numbers ending in 1-4 shall operate during Mondays and Tuesdays;
 - 2. Tricycles with Plate Numbers ending in 5-7 shall operate during Wednesdays and Thursdays
 - 3. Tricycles with Plate Numbers ending in 8-0 shall operate during Fridays, Saturdays and Sundays.
- B. Fare Rates. The fare rates in City Ordinance No. 21-08-2020 titled *“An Ordinance Fixing Fare Rates for Tricycles for Hire Operating Within Tuguegarao City”* shall be suspended for the meantime and, instead, the following fare rates, which shall be displayed inside the tricycle through the assistance of the Tricycle Regulation Unit:

NUMBER OF PASSENGERS	ROUTE	REGULAR FARE
ONE (1)	a. Within Poblacion Centro 1-12, including Ugac Sur and Ugac Norte, and Caritan Centro considered Poblacion	P25.00
	b. Outside Poblacion or after three (3) kilometers	P50.00
	c. After six (6) to seven (7) kilometers	P75.00
TWO (2)	a. Within Poblacion Centro 1-12, including Ugac Sur and Ugac Norte, and Caritan Centro considered Poblacion	P20.00 (per passenger)
	b. Outside Poblacion or after three (3) kilometers	P30.00 (per passenger)
	c. After six (6) to seven (7) kilometers	P40.00 (per passenger)

Notes:

- 1. *In case of two (2) passengers, one (1) passenger shall stay inside the tricycle while the other one (1) shall stay at the back of the tricycle driver provided there is an acetate or plastic cover to serve as a barrier between the driver and the two (2) passengers.*
- 2. *If one (1) passenger initially rides and along the way, another passenger rides, the fare shall be divided by the said two (2) passengers.*

- C. Operation of Talipapas. The following provisions shall be included:
 - 1. The operation of ambulant vendors shall be allowed provided they shall not occupy any part of the streets of Tuguegarao City and provided further that minimum health and safety protocols are observed.
 - 2. Street food vendors shall be prohibited in all streets surrounding the Tuguegarao City Commercial Center.
 - 3. The operation of talipapas shall not be an indicia of legitimacy of their operation and that they should comply with all national and local provisions of the Price Tag Law and the Consumer Act of the Philippines during the period of the pandemic.

Section 3. Penalties. For violations of Executive Order No. 21-2021 and/or this Ordinance, the following penalties shall be imposed:

- A. Mass Gathering
 - First Offense: A fine of Two Thousand Pesos (P2,000.00)
 - Second Offense: A fine of Three Thousand Pesos (P3,000.00)
 - Third Offense: A fine of Five Thousand Pesos (P5,000.00)

B. COVID Shield Control Pass (including illegal reproduction thereof)

- First Offense: A fine of Five Hundred Pesos (P500.00)
- Second Offense: A fine of One Thousand Pesos (P1,000.00)
- Third Offense: A fine of One Thousand Five Hundred Pesos (P1,500.00) and/or 30 days of imprisonment upon the discretion of the court

C. Curfew

- First Offense: A fine of Two Thousand Pesos (P2,000.00)
- Second Offense: A fine of Three Thousand Pesos (P3,000.00)
- Third Offense: A fine of Five Thousand Pesos (P5,000.00) and/or 30 days of imprisonment upon the discretion of the court

D. Any other provisions

- First Offense: A fine of Two Thousand Pesos (P2,000.00)
- Second Offense: A fine of Three Thousand Pesos (P3,000.00) and in case of business establishments, closure of said establishments.
- Third Offense: A fine of Five Thousand Pesos (P5,000.00) and/or 10 days of imprisonment upon the discretion of the court.

E. For establishments violating any of the provisions of Executive Order No. 21-2021 and/or this Ordinance

- First Offense: A Fine of Three Thousand Pesos (P3,000.00)
- Second Offense: A Fine of Five Thousand Pesos (P5,000.00)
- Third Offense: Closure of said business establishments

F. For violators of Sections 7, 8 and 9 of Executive Order No. 21-2021, a fine of Five Thousand Pesos (P5,000.00)

Section 4. All health and safety protocols during the Modified General Community Quarantine (MGCQ) promulgated/ordained by the National and Regional Inter-Agency Task Force, the Office of the City Mayor and all ordinances/resolutions approved by the Eighth City Council shall form part of this Ordinance.

Section 5. Public Hearing. This ordinance is enacted under unusual and extreme condition the country is experiencing in general and Tuguegarao City in particular as declared by the National Government through a number of proclamation orders and other rules and regulations promulgated by His Excellency President Rodrigo Duterte and the Provincial Government, hence, the public hearing shall be dispensed with, considering further the urgency and importance of the instant measure.

Section 6. Dissemination. Copies of this ordinance shall be posted in conspicuous places in the city and the City Information Office is directed to cause its massive and widest dissemination.


Section 7. Separability Clause. If any part or provision of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall remain in full force and effect.

Section 8. Repealing Clause. City Ordinances and administrative regulations or part/s thereof which are inconsistent with any provisions of this ordinance are hereby repealed, amended or modified accordingly.

Section 9. Effectivity Clause. This ordinance shall take effect on February 11, 2021 until the quarantine period shall be lifted by proper authorities.
