**AN ORDINANCE CREATING THE POSITION OF ONE (1) ATTORNEY II (SG-18)
 (CO-TERMINUS) UNDER THE CITY LEGAL OFFICE AND
 PROVIDING FUNDS THEREFOR**

WHEREAS, Section 76 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers LGUs to design and implement their own organizational structure and staffing pattern that will effectively address their development plans, objectives and priorities;

WHEREAS, the creation of a new position will augment manpower in the City Legal Office and improve the delivery of basic services particularly those which have to do with the programs and projects which the city mayor is empowered to implement and which the sanggunian is empowered to provide for under the Local Government Code of 1991;

WHEREAS, in the exigency of public service and to promote efficiency and an effective personnel force, there is a need to create a new position for the Local Government Unit of Tuguegarao and provide funds therefor.

NOW, THEREFORE, for and in consideration of the foregoing premises, be it **ORDAINED**, by the Sangguniang Panlungsod of Tuguegarao City in Regular Session assembled:

Section 1. Title. This Ordinance shall be known as “*An Ordinance Creating the Position of One (1) Attorney II (SG-18 (Co-terminus)) under the City Legal Office and Providing Funds Therefor.*”

Section 2. Creation of New Position. The position of one (1) Attorney II (SG-18) (co-terminus) is hereby created under the City Legal Officer.


Section 3. Qualifications of the Positions. All matters pertinent to recruitment and placement for the above created position shall be governed by Civil Service laws, rules and regulations and other related issuances.

Section 5. Funding. Funding for the salaries, benefits and other emoluments for the said position shall be appropriated in the Supplemental Budget subject to the availability of funds and Personnel Services Limitations.


Section 6. Effectivity. This ordinance shall take effect immediately upon approval.
