CITY RESOLUTION NO. 001-08-2021

RESOLUTION APPROVING THE DEED OF DONATION MADE AND ENTERED BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND PASCUAL CONSUMER HEALTHCARE CORPORATION AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID DEED OF DONATION

WHEREAS, Section 23 of the Local Government Code provides that the local chief executive may, upon the authority of the sanggunian, negotiate and secure financial grants or donations in kind in support of the basic services;

WHEREAS, pursuant to the above provision, the Tuguegarao City Government, through its City Mayor, accepts donations in kind or in cash especially in this difficult time of pandemic when the constituents are greatly affected;

WHEREAS, Pascual Consumer Healthcare Corporation, a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, shall be donating vitamin C and/or such other products classified as common medicines in support to the projects of the Tuguegarao City Government to benefit its constituents who are adversely affected by the COVID-19 pandemic;

WHEREAS, in order to make the said donation legally binding, there is a need for the Tuguegarao City Government and Pascual Consumer Healthcare Corporation to enter into a Deed of Donation;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, endorsed to the Eighth City Council the said Deed of Donation;

WHEREAS, the Eighth City Council during its 70th Regular Session held on January 6, 2021 found the terms and conditions in the Deed of Donation to be in order, with merit and beneficial to the constituents of the City;





RESOLVED FURTHER, to furnish a copy of this resolution to Pascual Consumer Healthcare Corporation for information.


On joint motion, **CITY RESOLUTION NO. 001-08-2021** was **UNANIMOUSLY APPROVED** under suspended rules.
