WHEREAS, Tuguegarao City experienced the worst massive flooding affecting almost all barangays and a great number of households and families on November 13-15, 2020 due to typhoons Quinta, Rolly, Siony, Tonio and Ulysses which brought continuous north-east monsoon rains and the opening of seven gates of the Magat Dam;

WHEREAS, the Eighth City Council approved during its Special Session held on November 14, 2020 Resolution No. 152-08-2020 Adopting and Approving CDRRM Council Resolution No. 8 declaring Tuguegarao City under a State of Calamity;

WHEREAS, Article 1, Section 25 (c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the President may, upon request of the local government unit concerned, direct the appropriate national agency to provide financial, technical, or other forms of

assistance to the local government unit and such assistance shall be extended at no extra cost to the local government unit concerned;

WHEREAS, considering the damages wrought by the massive flooding, President Rodrigo Roa Duterte felt the need to provide financial assistance to Tuguegarao City to address the immediate needs of the people affected by the flooding as well as to implement long term solution and provide future evacuation of people living in the hazard areas in Tuguegarao City;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, indorsed the Memorandum of Agreement for the said financial assistance to the Eighth City Council for approval and requested for an authority to sign the said MOA for and on behalf of the City Government of Tuguegarao;


WHEREAS, the Eighth City Council enacted City Resolution No. 257-08-2020 approving the Memorandum of Agreement (MOA) with the Office of the President for the grant of financial assistance amounting to Five Million Pesos in favor of the Tuguegarao City Government and granting authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the City Government the said MOA.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to extend warm and sincerest gratitude to the President of the Republic of the Philippines, Hon. Rodrigo R. Duterte, for the grant of financial assistance amounting to Five Million Pesos in favor of the Tuguegarao City Government to address the immediate needs of the people affected by the flooding as well as to implement a long term solution and provide future evacuation of people living in hazard areas.


On joint motion, **CITY RESOLUTION NO. 004-08-2021** was **APPROVED** under suspended rules.
