**WHEREAS**, Tuguegarao City experienced the worst massive flooding affecting almost all barangays and a great number of households and families on November 13-15, 2020 due to typhoons Quinta, Rolly, Siony, Tonio and Ulysses which brought continuous north-east monsoon rains and the opening of seven gates of the Magat Dam;

**WHEREAS**, the Eighth City Council approved during its Special Session held on November 14, 2020 Resolution No. 152-08-2020 Adopting and Approving CDRRM Council Resolution No. 8 declaring Tuguegarao City under a State of Calamity;

**WHEREAS**, in view of the massive flooding, a number of entities and individuals have extended assistance to the affected barangays and families through the City Government of Tuguegarao;

**WHEREAS**, Section 21 of Republic Act No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, provides that the LDRRMC may transfer funds to support the risk reduction work of other LDRRMCs which are declared under a state of calamity;

**WHEREAS**, the City of Ozamiz has provided P750,000.00 to support and equip the Tuguegarao City Government to combat and contain COVID-19 and address the needs of its people who have been affected by the massive flooding

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, was granted authority to accept donations in view of the declaration placing Tuguegarao City under a State of Calamity by virtue of Resolution 254-08-2020 approved by the Eighth City Council on November 17, 2020;

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, has requested the Eighth City for an authority to sign the Memorandum of Agreement with Ozamiz City;




