**WHEREAS**, His Excellency President Rodrigo Duterte issued Proclamation No. 922 on March 8, 2020 declaring a State of Public Health Emergency due to Novel Corona Virus Disease (COVID-19) while the World Health Organization (WHO) declared on March 12, 2020 that COVID-19 has become a “pandemic”;

**WHEREAS**, Tuguegarao City was placed under Enhanced Community Quarantine (ECQ) from March 17, 2020 to April 30, 2020, Modified Community Quarantine (MCQ) from May 1, 2020 to June 30, 2020, Modified General Community Quarantine (MGCQ) from July 1, 2020 to August 25, 2020 and General Community Quarantine (GCQ) from September 5, 2020 to October 2, 2020 and October 17, 2020 to present;

**WHEREAS**, due to increasing COVID-19 cases, Tuguegarao City was reverted to Modified Enhanced Community Quarantine (MGCQ) twice on August 26, 2020-September 4, 2020 and October 3, 2020-October 16, 2020;

**WHEREAS**, the City Government of Tuguegarao has instituted and implemented a number of mitigation programs and projects to contain the spread of COVID-19 cases;

**WHEREAS**, Pascual Consumer Healthcare Corporation, in support of the Tuguegarao City Government's programs and projects, has donated Vitamin C and such other Products Classified as Common Medicines to Tuguegarao City;

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, was granted authority to accept donations in support of the measures of the City Government of Tuguegarao to fight COVID-19 by virtue of Resolution 131-08-2020 approved by the Eighth City Council on April 6, 2020;

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano indorsed to the Eighth City Council the Deed of Donation for ratification;




On joint motion, **CITY RESOLUTION NO. 006-08-2021** was **APPROVED** under suspended rules.


