RESOLUTION RETURNING CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 16-2020 TITLED “REQUESTING THE EIGHTH TUGUEGARAO CITY COUNCIL TO RECALL CITY RESOLUTION NO. 244-08-2020 AND AUTHORIZING THE CITY MAYOR TO RENEGOTIATE THE LOAN APPLICATION WITH LAND BANK OF THE PHILIPPINES, TUGUEGARAO BRANCH UNDER THE RISE UP LGUS (RESTORATION AND INVIGORATION PACKAGE FOR A SELF-SUFFICIENT ECONOMY TOWARDS GROWTH UP GROWTH FOR LGUS) IN THE NEW AMOUNT OF THREE HUNDRED TWENTY-FIVE MILLION PESOS (PHP325,000,000.00)” FOR REFINEMENT

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, indorsed to the Eighth City Council CDC Resolution No. 16-2020 titled “*Requesting the Eighth Tuguegarao City Council to Recall City Resolution No. 244-08-2020 and Authorizing the City Mayor to Renegotiate the Loan Application with Land Bank of the Philippines, Tuguegarao Branch under the RISE UP LGUs (Restoration and Invigoration Package for a Self-sufficient Economy Towards Growth Up Growth for LGUs) in the New Amount of Three Hundred Twenty-Five Million Pesos (Php325,000,000.00);*”

WHEREAS, it was also recommended as stated in Committee Report that programs of work must also be submitted for presentation and discussion in plenary in the next regular session scheduled on January 19, 2021.


