WHEREAS, pursuant to the above provision, the Eighth City Council during its 131st Regular Session held on May 28, 2019 adopted and approved CDC Resolution No. 02-2019 titled “RESOLUTION ENDORSING TO THE 7th TUGUEGARAO CITY COUNCIL THE APPROVAL OF THE TUGUEGARAO CITY COMPREHENSIVE DEVELOPMENT PLAN (CDP) CY 2019-2025”;


