CITY RESOLUTION NO. 072-08-2021

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE TUGUEGARAO CITY GOVERNMENT AND THE DEPARTMENT OF SCIENCE AND TECHNOLOGY AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF TUGUEGARAO CITY THE SAID MOA

WHEREAS, Section 455 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that local chief executives shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, pursuant to the above provision, the City Mayor, Hon. Atty. Jefferson P. Soriano, continuously enters into contracts with different government and non-government agencies in order to strengthen the city’s partnerships and collaborations with the end-goal of improving its services to the people;

WHEREAS, to realize the said goal, the Tuguegarao City Government shall partner with the Department of Science and Technology (DOST), Regional Office No. 02 for its Smart City Framework for local government units recommending science, technology and innovation (STI) to address smart solutions to challenges in health, agriculture, traffic and transport, disaster and others;

WHEREAS, Tuguegarao City is named as one of the twenty-five (25) digital cities in the country which have the potential of becoming Smart Cities;

WHEREAS, in order to make the said partnership legally binding, there is a need for a Memorandum of Agreement to be signed by the Tuguegarao City Government and DOST;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, indorsed to the Eighth City Council the said MOA and requested for an authority for him to sign the said MOA;


WHEREAS, the Eighth City Council during its regular session held on January 19, 2021 found the terms and conditions of the Memorandum of Agreement to be in order, with merit and beneficial to the constituents of the City.
