
RESOLUTION URGING AND REQUESTING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, THE CITY INFORMATION OFFICE AND THE ASSOCIATION OF BARANGAY CHAIRS TO CONDUCT CONTINUOUS MASSIVE EDUCATION AND INFORMATION CAMPAIGN IN ALL THE BARANGAYS WITHIN THE TERRITORIAL JURISDICTION OF TUGUEGARAO CITY ON THE ENHANCED COMMUNITY QUARANTINE STATUS OF TUGUEGARAO CITY AND ON THE USE/WEARING OF FACE MASK AND FACE SHIELD, OTHER HEALTH PROTOCOLS AND PROHIBITION ON SOCIAL GATHERINGS

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, issued Executive Order No. 14, Series of 2021, "An Order Placing Tuguegarao City Under Enhanced Community Quarantine for Ten (10) Days and Setting Guidelines Thereof;"

WHEREAS, the Eighth City Council in its 72nd Regular Session held on January 19, 2021, by virtue of the Executive Order, adopted and approved the Ordinance Placing Tuguegarao City under Enhanced Community Quarantine (ECQ) for a period of Ten (10) days from 12:01 AM of January 20, 2021 until midnight of January 29, 2021 and upon concurrence of the CV-RIATF;

WHEREAS, during the said Regular Session, it was recommended to request the Office of the City Mayor the widest dissemination in all the barangays of Tuguegarao City all health and safety protocols during the ECQ.

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to urge the City Mayor, Hon. Atty, Jefferson P. Soriano, the City Information Office and the Association of Barangay Chairs to conduct continuous massive education and information campaign in all the Barangays within the territorial jurisdiction of Tuguegarao City on the Enhanced Community Quarantine status of Tuguegarao City and on the use/wearing of face mask and face shield, other health protocols and prohibition on social gatherings within Tuguegarao City.
