RESOLUTION ADOPTING AND APPROVING CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 05-2021 TITLED “RESOLUTION REQUESTING THE 8th TUGUEGARAO CITY COUNCIL TO APPROVE THE LIST OF PRIORITY PROJECTS TO BE FUNDED BY A LOAN IN THE AMOUNT OF THREE HUNDRED SEVENTY MILLION PESOS (P370,000,000.00) UNDER THE RISE UP LGUs (RESTORATION AND INVIGORATION PACKAGE FOR A SELF-SUFFICIENT ECONOMY TOWARDS UP GROWTH FOR LGUs) PROGRAM OF THE LAND BANK OF THE PHILIPPINES (LBP) AND TO AUTHORIZE THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO NEGOTIATE THE LOAN APPLICATION OF TUGUEGARAO CITY WITH THE LBP AND ENTER INTO A LOAN AGREEMENT SUBJECT TO THE APPROVAL OF THE CITY COUNCIL”

WHEREAS, the Land Bank of the Philippines has offered the City Government of Tuguegarao the Restoration and Invigoration Package for a Self-Sufficient Economy towards UP growth for LGUs (RISE UP LGUs) Lending Program in response to the ULAP’s (Union of Local Authorities of the Philippines) earnest request for the approval of interest subsidy that will make loans to LGUs more affordable, resulting in the provision of P1Billion to the Land Bank of the Philippines in interest subsidy for loans of LGUs under the “Bayanihan to Recover as One Act or BAYANIHAN 2;

WHEREAS, the City Government as part of its Economic Recovery Program has identified a list of priority projects that is conforming to the guidelines set by the Land Bank of the Philippines-Tuguegarao City Branch;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, indorsed to the Eighth City Council CDC Resolution No. 05-2021 dated January 22, 2021 for adoption and approval.


