RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE FOR THE ENHANCED KADIWA INCLUSIVE FOOD SUPPLY CHAIN PROGRAM AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MOA


WHEREAS, the Department of Agriculture (DA) is mandated to promote agricultural development by providing policy framework, public investments and support services needed for domestic and export-oriented business enterprises;

WHEREAS, the DA has launched the Enhanced Kadiwa Inclusive Food Supply Chain Program to ensure food availability and accessibility during the period of COVID-19 pandemic and beyond;

WHEREAS, under the Program, the DA provides financial grant assistance to participating eligible organizations and local government units (LGUs) to enhance their capacities in value-adding activities in the food supply chain from aggregation, processing, packing, storing, warehousing and transport to distribution;

WHEREAS, the DA shall provide financial support on fund transfer basis to the LGU-Tuguegarao City in the amount of One Million Pesos (P1,000,000.00) as financial grant which will be utilized in accordance with the Work and Financial Plan;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, indorsed to the Eighth City Council the Memorandum of Agreement and requested to grant him an authority to sign for and on behalf of the Tuguegarao City Government the said MOA;



WHEREAS, the Eighth City Council during its Special Session held on February 04, 2021 found the terms and conditions of the Memorandum of Agreement to be in order, with merit and beneficial to the constituents of the City. NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to approve the Memorandum of Agreement with the Department of Agriculture for the Enhanced Kadiwa Inclusive Food Supply Chain Program and granting authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, for and on behalf of the Tuguegarao City Government the said MOA.
