**RESOLUTION ADOPTING AND APPROVING THE TRICYCLE ROUTE PLAN  
 OF TUGUEGARAO CITY**

**WHEREAS**, Section 17 of the Local Government Code mandates local government units particularly cities to provide adequate, effective and efficient transportation facility that would provide access and mobility for its people to pursue socioeconomic activities as reflected in the Comprehensive Land Use Plan (CLUP) and Zoning Ordinance;

**WHEREAS**, the major means of transportation within the city is the tricycle;

**WHEREAS**, as Regional Government Center and Center of Education and Commerce, Tuguegarao City recognizes the need for a Tricycle Route Plan for effective and orderly transport mechanism;

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, indorsed to the Eighth City Council the said Tricycle Route Plan;

**WHEREAS**, the Eighth City Council during its Special Session held on February 11, 2021 finds it imperative to have a Tricycle Route Plan since tricycle is the primary means of transportation in Tuguegarao;

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to adopt and approve the said Tricycle Route Plan of Tuguegarao City.

**RESOLVED FURTHER**, that the Tricycle Route Plan shall form an Integral Part of City Ordinance No. 047-08-2019 titled "*AN ORDINANCE ADOPTING THE ROAD SAFETY CODE OF TUGUEGARAO CITY, PROVIDING PENALTIES FOR THE VIOLATION THEREOF, AND APPROPRIATING FUNDS FOR THIS PURPOSE.*"
