**WHEREAS**, the 2021-2026 Local Disaster Risk Reduction and Management Plan of Tuguegarao City was approved during the 74<sup>th</sup> Regular Session of the Eighth City Council held on February 09, 2021;

**WHEREAS**, the Committee of the Whole in its meeting held on February 10, 2021 deemed it necessary to create an oversight committee on the implementation of the said Plan.

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to create an Oversight Committee on the implementation of the 2021-2026 Local Disaster Risk Reduction and Management Plan.

**RESOLVED FURTHER**, that the following committees of the Eighth City Council shall compose the oversight committee pertaining specific thematic areas:

Thematic Area 1: Disaster Prevention and Mitigation

- Committee on Climate Change, Environmental Protection and Ecology
- Committee on Infrastructure and Public Utilities

Thematic Area 2: Disaster Preparedness and Mitigation

- Committee on Public Safety and Disaster Preparedness
- Committee on Barangay Affairs

Thematic Area 3: Disaster Response and Mitigation

- Committee on Social Services
- Committee on Public Information

Thematic Area 4: Disaster Resources and Rehabilitation

- Committee on Agriculture and Food, Market and Livestock Auction Center
- Committee on Cooperatives and Livelihood


