WHEREAS, the Eighth City Council during its 3rd Regular Session held on July 16, 2019 approved City Resolution No. 121-08-2019 “*A Resolution Approving the Composition of the Regular Committees of the Eighth City Council*”;

WHEREAS, Hon. Victor V. Perez took his oath of office as a City Councilor last February 4, 2021 replacing Hon. Victor Herbert N. Perez who peacefully joined His Creator last August 17, 2020;

WHEREAS, the untimely demise of Hon. Victor Herbert N. Perez created vacancies in committees;

WHEREAS, Hon. Victor V. Perez, being the new member of the Eighth City Council, shall be the Chair of the Committee on Trade, Commerce and Industry and Member of the Committee on Health and Sanitation, Committee on Public Safety and Order and Disaster Preparedness, Committee on Agriculture and Food, Market and Livestock Auction Center, Committee on Barangay Affairs, Committee on Cooperatives and Livelihood and Committee on Public Information;

WHEREAS, in order to make the chairmanship and membership of Hon. Victor V. Perez formal and legal, there is a need to amend City Resolution No. 121-08-2019.

WHEREAS, the Eighth City Council during its 76th Regular Session held on February 23, 2021 approved the herein resolution.


