WHEREAS, Comprehensive Development Plan (CDP) CY 2019-2025 was approved by the City Development Council in CDC Resolution No. 02 dated May 20, 2019 and adopted by the 7th Tuguegarao City Council in City Resolution No. 099-2019;

WHEREAS, the Executive-Legislative Agenda (ELA) CY 2019-2022 was approved by the City Development Council in CDC Resolution No. 05-2019 and adopted by the Tuguegarao 8th City Council in City Resolution No. 204-08-2019;

WHEREAS, the Local Government Investment Program (LGIP) CY 2019-2022 was approved by the City Development Council in CDC Resolution No. 06-2019 and adopted by the Tuguegarao 8th City Council in City Resolution No. 204-08-2019;

WHEREAS, the Annual Development Plan (ADP) was approved by the City Development Council in CDC Resolution No. 07-2021 and adopted by the 8th City Council in City Resolution No. 234-08-2021;

WHEREAS, the construction of a Cooperative Multi-Purpose Building was not included among the Programs, Projects and Activities (PPAs) in the approved abovementioned plans of Tuguegarao City;

WHEREAS, City Mayor Hon. Atty. Jefferson P. Soriano has Endorsed to the Eighth City Council CDC Resolution No. 09-2021 titled “Resolution Endorsing to the Eighth Tuguegarao City Council the


WHEREAS, the Committees find the subject matter to be meritorious and beneficial to Tuguegarao City Government and its constituents particularly the tobacco farmers.
