WHEREAS, GEN. BENITO ANTONIO TEMPLO DE LEON is a graduate of Philippine Military Academy, Class of 1981 and was assigned mostly in Mindanao and Visayas;

WHEREAS, GEN. BENITO ANTONIO TEMPLO DE LEON has served his hometown as a Commander of the 5th Infantry Division of Philippine Army based at Camp Melchor Dela Cruz UPI Gamu, Isabela in charge of all army forces in Northern Luzon;

WHEREAS, the appointment of **GEN. BENITO ANTONIO TEMPLO DE LEON** as the new DENR Undersecretary gives pride and honor to Tuguegarao City.




