## EXECUTIVE ORDER NO. <u>106</u> Series of 2020

## "AN ORDER EXTENDING THE TOTAL LOCKDOWN AT ZONE 4, BARANGAY CENTRO 09, TUGUEGARAO CITY, CAGAYAN FOR FIVE (5) DAYS"

WHEREAS, after the declaration of the 2019 Corona Virus Disease or the COVID-19 as a pandemic by the World Health Organization, the number of confirmed cases throughout the country has increased alarmingly;

WHEREAS, the Office of the President, through Executive Order No. 112 Series of 2020, authorizes Mayors of Cities and Municipalities to impose, lift or extend Enhanced Community Quarantine in barangays, upon the concurrence of the relevant regional counterpart body of the IATF;

WHEREAS, as per Memorandum Circular No. 02, s 2020 of the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID) National Task Force COVID-19 (NTF COVID-19), a sparsely- populated barangay with population density below 1,000/km<sup>2</sup> shall be categorized as CrZ if at least two (2) clusters of cases, composed of wither suspect, probable and/or confirmed COVID-19, are present in at least two (2) different sitios, puroks or blocks, whichever is applicable;

WHEREAS, Section 6.2 of the said NTF COVID-19 Memorandum provides that LGUs shall be categorized into four (4) zoning classifications, namely. Critical Zone (CrZ), Containment Zone (CZ), Buffer Zone (BZ) and Areas Outside Buffer Zone (OBZ);


WHEREAS, Executive Order No. 97 Series of 2020 entitled "AN ORDER EXTENDING THE TOTAL LOCKDOWN OF BARANGAY CENTRO 09, TUGUEGRAO CITY CAGAYAN FOR SEVEN (7) DAYS" was issued on September 23, 2020 extending its classification as Critical Zone based on classifications set forth by the National Task Force, for seven days or until September 30, 2020;

WHEREAS, the Tuguegarao City Inter-Agency Task Force Against COVID-19 recommended an extension of total lockdown over a portion of Barangay Centro 09, which is at Zone 4, because of the existing number of confirmed cases in the said area, to complete contact tracing on all individuals who had close contact with the confirmed cases and to further arrest the transmission of the virus;

**NOW, THEREFORE, I, ATTY. JEFFERSON P. SORIANO,** by virtue of the powers vested in me by law as City Mayor of Tuguegarao City, Cagayan, do hereby order the following:

**Section 1**. *EXTENSION OF TOTAL LOCKDOWN*. There shall be an extension of total lockdown over a portion of Barangay Centro 09 which is at Zone 4 in Barangay Centro 09, Tuguegarao City (from corner Maura Street to Rizal Street and from corner Maura Street to Blumentrit Street) for a period of five (5) days. Entrance and exit therefrom of all individuals whether a resident or not, shall be strictly prohibited.

All residents are hereby ordered to stay inside their respective residences and must submit and duly comply with all rules and regulations pertaining to the total lockdown.



Section 2. *Community Curfew*. Curfew from 6 o'clock in the evening to 6 o'clock in the morning is hereby imposed within Zone 4 of Barangay Centro 09. All business establishments within the said zone are prohibited to operate during the curfew hours.

**Section 3.** *Exemptions*. Only emergency cases which require immediate medical and hospital attention as determined by the proper health authorities are exempted from this Order.

Physicians, nurses and other health workers residing in the area are allowed to exit, however, they will no longer be allowed to enter the area during the duration of the lockdown.

**Section 4.** *Violation*. Any person violating this Order shall be dealt with in accordance with pertinent provisions of law.

Section 5. *Enforcement / Implementation*. This Order shall be implemented by the Barangay Officials of Barangay Centro 09, Philippine National Police, and Public Safety and Security Office, City Health Office, City General Services Office.

*Section 6. Operational Plan.* The Operational Plan attached as Annex "A" of Executive Order No. 90 Series of 2020, shall govern the movements and activities within Zone 4 in Barangay Centro 9 during the five (5) day extension of the total lockdown.

**Section 7.** *Repealing Clause.* All prior issuances or parts thereof inconsistent with this Executive Order are hereby repealed, amended or otherwise modified accordingly.

Section 8. Effectivity. This Order shall take effect on

The hereby adopted zoning containment classification and the corresponding type of community quarantine shall take effect on September 30, 2020 and shall be valid for five (5) days, subject to extension based on the assessment and re-categorization conducted by the City Task Force against COVID-19.
