



"AN ORDER AMENDING EXECUTIVE ORDER NO. 34-2020 ENTITLED 'AN ORDER LIMITING THE PERIOD OF OPERATION OF THE TUGUEGARAO CITY CENTRAL PUBLIC MARKET (DON DOMINGO), TUGUEGARAO CITY COMMERCIAL CENTER, AND ALL TALIPAPA'S IN TUGUEGARAO CITY'''

WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the *Local Government Code of 1991, "states that the Local Government Units are authorized to* exercise powers necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of general welfare;"

WHEREAS, in response to the growing concern over the outbreak of COVID-19, President Rodrigo R. Duterte through Proclamation No. 922, declared the Philippines under State of Public Health Emergency;

WHEREAS, the Office of the President through the Executive Secretary issued a Memorandum on March 16, 2020 entitled: *Community Quarantine over the entire Luzon and further Guidelines for the Management of the Corona Virus Disease (COVID-19) situation,* which directed all Local Government Units (LGUs) to adopt, coordinate and implement the guidelines on the imposition of Stringent Social Distancing Measures over the entire Luzon effective 12 AM of 17 March 2020 and expiring on 12 AM of 13 April 2020;

WHEREAS, a STATE OF PUBLIC HEALTH EMERGENCY has been declared in Tuguegarao City by virtue of Executive Order No. 15-2020, City Resolution No. 97-08-2020 and CDDRMC Resolution No. 02-2020;

WHEREAS, Executive Order No. 28 implemented the strict home quarantine in all households beginning March 17, 202 - April 14, 2020 in Tuguegarao City and provided exemptions thereof;

WHEREAS, Executive Order No. 34-2020 entitled "An Order Limiting the Period of Operation of the Tuguegarao City Central Public Market (Don Domingo), Tuguegarao City Commercial Center, and all Talipapa's in Tuguegarao City" was issued to limit the operation of the Tuguegarao City Central Public Market (Don Domingo) and the Tuguegarao City Commercial Center from 5 A.M. to 10 A.M. and all talipapas in the city from 3 P.M. to 6 P.M.;

NOW, THEREFORE, I, ATTY. JEFFERSON P. SORIANO, City Mayor of Tuguegarao, by virtue of the powers vested in me by the Constitution and the laws, do hereby order the following:

Section 1. Period of Operation:

a. Tuguegarao City Central Public Market (Don Domingo). Market Operations shall start at 5:00 A.M. to 12:00 noon, only; from Monday to Sunday.

b. **Tuguegarao City Commercial Center** (formerly MOVA). Market Operations for those selling meat, fish, poultry, and vegetables, inside the center and within the vicinity of the center, shall likewise start at 5:00 A.M. to 12:00 noon, only; daily, from Monday to Sunday. All other stalls not engaged in the sale of vegetables, meat, fish, and poultry, and other essential necessities (foods and medicines) are hereby prohibited from operating within the period of the "enhanced community quarantine."

Section 2. Exemptions. Exempted from this Order are the following:

- a. At the Tuguegarao City Central Public Market (Don Domingo) Mariton's Grocery and the other similar grocery stores engaged in the sale of food and grocery items, only.
- b. At the Tuguegarao City Commercial Center (formerly MOVA) the SAVEMORE Supermarket located at the basement; Mariton's Grocery along Gomez Street, Puregold Grocery along Gonzaga Street, Mariton Fresh along Bonifacio Street, and all other grocery stores within the same vicinity engaged in the sale of food items, only.

Section 3. *Talipapa*. All *talipapas* in every barangay in Tuguegarao City are hereby allowed to open within the same period of time, from 5:00 a.m. to 12:00 noon, only.

Section 4. *Violation*. Any person violating this provisions of this Order shall be dealt with in accordance with pertinent provisions of law.

Section 5. *Enforcement / Implementation*. This Order shall be implemented by the Office of the Market Administrator, Philippine National Police, Public Safety and Security Office, and Punong Barangays and Barangay Tanods in their respective jurisdictions.

Section 6. *Repealing Clause.* All prior issuances or parts thereof inconsistent with this Executive Order are hereby repealed, amended or otherwise modified accordingly.

Section 7. *Effectivity*. This Order shall take effect on **MARCH 26**, **2020** (THURSDAY) and shall remain in effect until the end of the Enhanced Community Quarantine.
