EXECUTIVE ORDER NO. 47 Series of 2021

"AN ORDER SETTING GUIDELINES FOR THE STRICT IMPLEMENTATION OF COVID SHIELD CONTROL PASS IN TUGUEGARAO CITY"

WHEREAS, under Section 15, Article II of the 1987 Constitution, it is the State's Policy to protect and promote the right to health of the people;

WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, "states that the Local Government Units are authorized to exercise powers necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of general welfare;"

WHEREAS, the World Health Organization has declared Corona Virus Disease (COVID-19) as a pandemic and in response thereto, President Rodrigo Roa Duterte through Proclamation No. 929, Series of 2020, declared the Philippines under State of Public Health Emergency, which was further extended by Presidential Proclamation No 1021, Series of 2020;

WHEREAS, as of 5 pm of March 19, 2021, we have recorded a total of two hundred sixty (260) confirmed COVID-19 cases in the city;

WHEREAS, due to the increasing number of confirmed COVID-19 cases, there is a need to regulate the movement of people as a mitigating measure to combat the rise of the COVID-19 cases in the city;

NOW, THEREFORE, I, ATTY. JEFFERSON P. SORIANO, City Mayor of Tuguegarao, by virtue of the powers vested in me by the Constitution and the laws, do hereby order the following:

Section 1. Guidelines for the use of COVID Shield Control Pass. The use of the COVID Shield Control Pass shall be strictly implemented starting 12:01 am of March 22, 2021(Monday) in Tuguegarao City except visitor's pass.

Section 02. Non-Residents of Tuguegarao City. For non-residents of Tuguegarao City, any identification card showing that you are a resident of any municipality or city outside Tuguegarao City shall be presented in lieu of the visitor's pass.

For non-residents who are working in Tuguegarao City, the presentation of their company I.D shall suffice.

Section 03. Exceptions. In lieu of the COVID Shield Control Pass, Government Employees including members of the academe and frontliners may present their company IDs in transacting business with any establishments in the city.

Section 04. Violations. Any person violating any provisions of this Order shall be dealt with in accordance with pertinent provisions of law.

Section 05. Enforcement / Implementation. The Philippine National Police - Tuguegarao City, Public Safety and Security Office, Punong Barangays and Barangay Tanods in their respective jurisdictions shall ensure the strict observance of these guidelines.

Section 06. Repealing Clause. All prior issuances or parts thereof inconsistent with this Executive Order are hereby repealed, amended or otherwise modified accordingly.

Section 07. Effectivity. This Executive Order shall take effect starting 12:01 AM of March 22, 2021.
