EXECUTIVE ORDER NO. 54
Series of 2021

**“AN ORDER PLACING TUGUEGARAO CITY UNDER ENHANCED
COMMUNITY QUARANTINE FOR TEN (10) DAYS AND SETTING GUIDELINES
THEREOF”**

WHEREAS, under Section 15, Article II of the 1987 Philippine Constitution it is the State’s Policy to protect and promote the right to health of the people;

WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the *Local Government Code of 1991*, “states that the Local Government Units are authorized to exercise powers necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of general welfare;”

WHEREAS, the World Health Organization has declared Corona Virus Disease (COVID-19) as a pandemic and in response thereto, President Rodrigo R. Duterte through Proclamation No. 929, Series of 2020, declared the Philippines under State of Public Health Emergency, which was further extended by Presidential Proclamation 1021 Series of 2020;

WHEREAS, there has been an overwhelming increase of confirmed COVID-19 cases in Tuguegarao City for the past fourteen (14) days wherein we have recorded a total of five hundred-four (504) confirmed cases with an attack rate averaging to thirty - six cases (36) per day;

WHEREAS, as of March 27, 2021, Tuguegarao City has recorded one hundred thirteen (113) confirmed cases, bringing the total number of active cases in the city to five hundred-thirteen (513);

WHEREAS, this is the highest number of active cases and the highest number of new cases recorded in a day since the start of the pandemic in March 2020;

WHEREAS, the Tuguegarao City Inter-Agency Task Force Against COVID-19 during their meeting held on March 28, 2021, recommended the elevation of the status of Tuguegarao City from Modified General Community Quarantine (MGCQ) to Enhanced Community Quarantine (ECQ), due to the alarming increase in the number of confirmed cases and due to the current surge of asymptomatic and mild cases as reported by the City Health Officer;

WHEREAS, the undersigned, in a letter dated March 28, 2021, sought the approval of Governor Manuel N. Mamba for the imposition of Enhanced Community Quarantine (ECQ) in Tuguegarao City for a period of ten (10) days starting 12:01 AM of March 30, 2021 (Tuesday) until midnight of April 08,2021 (Thursday), which he approved and later concurred by the Cagayan Valley Regional Inter-Agency Task Force on March 28, 2021.



NOW, THEREFORE, I, ATTY. JEFFERSON P. SORIANO, City Mayor of Tuguegarao, by virtue of the powers vested in me by the Constitution and the laws, do hereby order the following:

Section 1. *Enhanced Community Quarantine (ECQ)*. Tuguegarao City is hereby placed under Enhanced Community Quarantine (ECQ) starting 12:01 AM of March 30, 2021 (Tuesday), and shall be enforced for a period of ten (10) days until midnight of April 08, 2021 (Thursday).

Section 2. *Guidelines to be Observed under the Enhanced Community Quarantine.* The following guidelines and protocols shall be observed during the Enhanced Community Quarantine (*Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines as Amended*):

1. Minimum public health standards shall be complied with at all times for the duration of the Enhanced Community Quarantine, i.e. wearing of face mask at all times, and when in public places, together with face shield; physical distancing; washing of hands regularly; using alcohol or disinfectants.
2. Strict home quarantine shall be observed in all households, and the movement of all residents shall be limited to accessing essential goods and services, and for work in permitted offices or establishments as well as activities listed hereunder.

Only essential travels are allowed in travelling in and out of Tuguegarao City such as, but not limited to:

- a. Accessing basic or essential necessities (e.g. food and medicine);
 - b. Attending to any medical need, including donating blood or attending medical appointments/ check-ups;
 - c. Accessing public and other government-related services including bank-related-transactions;
 - d. Reporting to work or any travel in relation to work;
 - e. Accessing products or services involved in agriculture, forestry, and fishery as components of the food value chain;
 - f. Accessing supply equipment or products necessary to perform construction or maintenance works, such as cement and steel, or spare parts;
 - g. Accessing the judicial system or any other services for the protection of legal rights of a person
3. Any person below eighteen (18) years old, those who are over sixty-five (65) years of age, those with immunodeficiency, comorbidity, or other health risks, and pregnant women, including lactating mothers, including any person who resides with the aforementioned, shall be required to remain in their residences at all times, **except** when indispensable under the circumstances for obtaining essential goods and services, or for work in industries and offices or such other activities permitted in this Executive Order.

4. The following establishments, persons, or activities are allowed to operate, work or be undertaken for the duration of ECQ:

A. With full on-site capacity:

- i. Public and private hospitals;
- ii. Health, emergency and frontline services, including those provided by dialysis centers, chemotherapy centers, and the like;
- iii. Manufacturers of medicines, medical supplies, devices and equipment, including suppliers of input, packaging, and distribution;
- iv. Industries involved in agriculture, forestry, and fishery and their workers, including farmers, Agrarian Reform Beneficiaries (ARBs), fisherfolk, and agri-fishery stores, and such other components of the food value chain;
- v. Logistics service providers (delivery and courier services, cargo handling, warehousing, trucking, freight forwarding, port operations and shipping line);
- vi. Essential and priority construction projects, whether public or private, in accordance with the guidelines issued by the Department of Public Works and Highways;
- vii. Manufacturing related to food and other essential goods such as but not limited to soap and detergents, disinfectants, and personal hygiene products;
- viii. Companies that manufacture and/or supply equipment or products necessary to perform construction or maintenance works, such as cement and steel, or spare parts;
- ix. Essential retail trade and service establishments such as:
 - a. public markets
 - b. supermarkets
 - c. grocery stores
 - d. convenience stores
 - e. pharmacies or drug stores
 - f. laundry shops
 - g. water-refilling stations
- x. Food preparation establishments such as commissaries, restaurants, and eateries, **but limited to take-out and delivery**;
- xi. Public and private financial service providers involved in the distribution of government grants and amelioration subsidies; and

B. The following shall be allowed to operate at fifty percent (50%) on-site capacity:

- i. Media establishments and their total permanent staff complement, inclusive of reporters and other field employees

C. With a skeleton workforce (not exceeding 20% of the on-site capacity) :

- i. Dental, rehabilitation, optometry clinic and other medical clinics: *Provided* that there is strict observance of infection prevention and control protocols. *Provided, further*, that dental procedures shall be **limited to emergency cases only and that the wearing of full Personal Protective Equipment (PPEs) by dentists and attendants shall be mandatory.** *Provided finally* that home service therapy for Persons With Disabilities (PWDs) shall be allowed;
- ii. Veterinary Clinics;
- iii. Banks, capital markets, money transfer services, including pawnshops only insofar as performing money transfer functions, microfinance institutions and credit cooperatives, including their armored vehicle if any;
- iv. Water supply and sanitation services and facilities, including waste disposal services, as well as property management and building utility services;
- v. Energy and power companies, their third-party contractors and service providers, including employees involved in electric transmission and distribution, electric power plant and line maintenance, electricity market and retail suppliers, as well as those involved in the operations, trading and delivery of coal, oil, crude or petroleum and by-products (gasoline, diesel, liquefied petroleum gas, jet oil, kerosene, lubricants), including gasoline stations, refineries and depots or any kind of fuel used to produce electricity;
- vi. Telecommunications companies, internet service providers, cable television providers, including those who perform indirect services such as the technical, sales, and other support personnel, as well as the employees of their third-party contractors doing sales, installation, maintenance and repair works;
- vii. Funeral and embalming services. *Provided*, that there is shuttle service and/or housing accommodation for their personnel and staff;
- viii. Pastors, priests, rabbis, imams or such other religious ministers and their assistants whose movement shall be **related to the conduct of necrological or funeral rites.** Corollarily, **immediate family members of the deceased** who died of causes other than COVID-19 shall be allowed to move from their residences to attend the wake or interment of the deceased upon satisfactory proof of their relationship with the latter, fully complying with social distancing measures for the duration of the activity;
- ix. Security personnel licensed by the Philippine National Police - Supervisory Office for Security and Investigation Agencies;
- x. Printing establishments authorized by the Bureau of Internal Revenue or other government agencies to print accountable forms and other security documents including the printing of modules and educational materials for the use of the Department of Education ;
- xi. Wholesale and retail trade of motor vehicles, motorcycles and bicycles, including their parts and components;
- xii. Establishments engaged in repair and maintenance of motor vehicles, motorcycles and bicycles including vulcanizing shops, battery repairs, auto repair shops;

- xiii. Establishments engaged in the retail of appliances and other home equipments and the repair and maintenance of machinery and equipment, including those engaged in the repair of computers and household fixtures and equipment; and
- xiv. Real estate activities limited to leasing only

For the purposes of the foregoing, transit by permitted persons to and from the above establishments anywhere within the area covered by ECQ shall be allowed.

5. Agencies and instrumentalities of the government, including GOCCs, as well as LGUs may operate with skeleton workforce **but not exceeding twenty percent (20 %) of their on-site capacity**, in combination with other alternative work arrangements as approved by the head of agency.

Provided, however, that the Department of Health and the Philippine National Police shall be allowed to operate at **full on-site capacity**;

Provided further that the **Department of Education, Commission on Higher Education, Department of Agriculture, Bureau of Internal Revenue, Department of Social Welfare and Development (DSWD)** and other agencies directly involved in health, peace and order security, emergency frontline services, border control, or other critical services may adopt a different on-site capacity **but shall not exceed fifty percent (50%)**.

6. The co-equal or independent authority of the Legislature (Senate and the House of Representatives), the Judiciary (the Supreme Court, Court of Appeals, Court of Tax Appeals, Sandiganbayan, and the lower courts), the Office of the Ombudsman, and the Constitutional Commissions, to implement any alternative work arrangements, is recognized.
7. Officials and employees of foreign diplomatic missions and international organizations accredited by the Department of Foreign Affairs (DFA), whenever performing diplomatic functions and subject to the guidelines issued by the DFA, may operate with a skeleton workforce.
8. Only hotels or accommodation establishments with valid Department of Tourism (DoT) Accreditation shall be allowed to accommodate guests and clients for legitimate purposes under a state of public health emergency. The operation of such hotels and accommodation establishments, as well as ancillary establishments within their premises such as restaurants, cafes, gyms, spas, function halls, and the like, shall be subject to guidelines issued by the DoT and the IATF.
9. Face-to-face or in-person classes at all levels shall be suspended.
10. Public transportation shall be allowed to operate on a very limited basis (tricycles only). The following coding scheme shall be followed:

Tricycles may accommodate two (2) passengers at any one time, *provided* that the passengers wear the required face mask and faceshield, *provided further* that one passenger must ride inside the tricycle and the other is at the back of the driver, *provided finally* that protective barriers are installed between the driver and the passengers.

Other means of public transportation such as vans, buses and taxis shall be allowed to enter and operate provided they have a Special Permit to operate issued by the LTFRB and will strictly comply with the prescribed health protocols of the city and shall be limited to **50 % of the seating capacity** of the vehicle.

This notwithstanding, commissioned shuttle services for employees of permitted offices or establishments, as well as point-to-point transport services provided by the government shall be allowed to operate, giving priority to healthcare workers.

The aviation sector of public transportation shall be allowed to operate at such capacity and protocols in accordance with guidelines issued by the Department of Transportation (DOTr).

11. The use of a **private transport** shall be governed by the *Omnibus Public and Private Transport Protocols During ECQ, MECQ and GCQ, set by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID) and the Department of Transportation (DOTr), to wit:*

- a. Rented Company shuttles shall secure a special permit from the LTFRB and shall carry fifty percent (50%) of the shuttle's passenger capacity;
- b. Personal vehicles shall carry those individuals/ workers of permitted sectors, with a maximum of fifty percent (50%) of the vehicle's passenger capacity;
- c. Use of bicycles and motorcycles is allowed provided that the rider is an APOR or an Authorized Person outside Residence or when used for work purposes or accessing essential needs and necessities;

Back riding shall be allowed provided that a Barangay Certification must be secured certifying that the driver and the back rider are members of the same household.

12. Law enforcement agencies shall recognize any of the following IDs:

- a. IATF IDs issued by the regulatory agencies with jurisdiction over permitted establishments or persons;
- b. *Bona fide* IDs issued by establishments exempted from the strict home quarantine requirement;
- c. RapidPass IDs;
- d. Integrated Bar of the Philippines ID for lawyers who will provide legal representation necessary to protect rights of persons under custodial investigation, to bail, and to counsel during inquest proceedings; or
- e. **COVID Control Shield Pass** issued by the Tuguegarao City Government.

No other IDs or passes specifically exempting persons from community quarantine shall be required of workers of permitted establishments and/or offices without prejudice to requiring the presentation of other documents establishing the nature of their work.

13. The movement of cargo vehicles shall be unhampered. Cargo vehicles as well as vehicles used by public utility companies, BPOs, and export-oriented establishments shall not be subject to an ID system.
14. Government offices and private corporations are encouraged to process payrolls online. Payroll managers, and. Such other employees shall be allowed to travel to process and print payrolls during ECQ.
15. Other exemptions from the home quarantine requirement through previous IATF resolutions or issuances by the Office of the President shall be honored.
16. Following the provisions of the Bayanihan To Heal as One (Bayanihan 1), Bayanihan to Recover as One Act (Bayanihan 2) and the resolutions issued by the COVID-19 Inter-Agency Task Force for the Management of Emerging Infectious Diseases, any disconnection activities for overdue electricity or water bills shall be suspended until April 8, 2021.

Section 3. *Interzonal Movement of Authorized Persons Outside Residences (APOR).*

The movement of the following authorized persons outside residences (APOR) within and across areas placed under any form of community quarantine shall be permitted:

1. Health and emergency frontline services personnel;
2. Government officials and government frontline personnel;
3. Duly-authorized humanitarian assistance actors (HAAs);
4. Persons travelling for medical or humanitarian reasons;
5. Persons going to the airport for travel abroad; and
6. Anyone crossing zones for work or business permitted in the zone of destination, and going back home.

Section 4. Returning Residents, Returning Overseas Filipinos (ROFs) and Arriving Businessmen. Returning Residents, Returning Overseas Filipinos (ROFs) and Arriving Businessmen shall be allowed entry during the duration of the ECQ provided prior coordination is made with our **Command Center Hotline :+63956- 347-7981** and will abide with the existing health protocols established by the city such as online registration.

For Arriving Businessmen, submission of their itinerary shall also be required.

Section 5. Liquor Ban. A Citywide Liquor Ban shall be imposed while Tuguegarao City is under Enhanced Community Quarantine (ECQ). The sale of alcoholic beverages in business establishments and drinking of alcoholic beverages in public places shall be strictly prohibited.

Section 6. Mass Gathering. Gatherings outside of residences shall be prohibited.

Gatherings at residences with any person outside of one's immediate household, shall likewise be prohibited.

All religious gatherings shall be limited to virtual masses only except for restricted masses for the dead.

ONLY immediate family members of the non-COVID-19 deaths shall be allowed during the internment and burial. Funeral wakes shall be limited for seventy-two (72) hours only. Funeral marches shall be strictly prohibited.

Gatherings that are for the provision of critical government services and authorized humanitarian activities shall be allowed **at a maximum of ten (10) persons ONLY**. *Provided that*, the conduct of humanitarian activities such as relief distributions requires prior coordination and approval from the Tuguegarao City Government, through the Office of the City Mayor.

Section 7. Exit and Re-Entry of Residents. Residents of Tuguegarao City who are travelling outside Tuguegarao City or re-entering the city during the period of ECQ shall be governed by the following protocols:

- A. **EXIT.** For residents who are permitted to travel outside Tuguegarao City during the period of ECQ shall be subjected to the existing protocols of the receiving LGU;

Only essential travel outside the city shall be allowed;

For those travelling outside Tuguegarao City, they must secure a Travel Pass through the online travel pass application thru <https://forms.gle/pK6RqXkyw6Hy87k48> or at the Barangay Hall of their respective barangays before their scheduled travel. Before securing Travel Pass, they must first secure a Certification signed by their Barangay Midwife or Barangay Captain, certifying that they are not considered PUM, PUI, suspected cases or part of any contact tracing activity.

- B. **RE-ENTRY.** Residents of Tuguegarao City shall be allowed re-entry in the city upon presentation of the Travel Pass (the same document they used when they travelled outside the city)

For those who are working outside the city, they need to present a Certificate of Employment issued by their respective HR Offices or any valid company I.D, proving that they are bonafide residents of Tuguegarao City but working outside the city.

Section 8. Entry of Non-Residents. Non-Residents of Tuguegarao City shall be allowed entry in the City provided that they shall present either of the following:

- A. For those working in Tuguegarao City, either in the government or private sector, presentation of their valid company ID shall suffice;
- B. For those coming from any other municipalities within the Province of Cagayan to Tuguegarao City for nonwork-related purposes, valid travel documents (i.e. Travel Pass and Health Declaration from the LGU of Origin) must be presented at the border checkpoints;
- C. For those coming from areas outside the Province of Cagayan to Tuguegarao City, they must comply with the provisions of Executive Order No. 46, series of 2021, issued by the undersigned.

Before allowing entry, they are required to **present the original copy** of the Travel Documents and **leave a photocopy** of their travel documents at the checkpoints.

The entry of Non-Residents for nonwork-related purposes shall be limited to accessing essential needs and necessities and for emergency medical reasons **ONLY**.

All persons passing through Tuguegarao City shall be allowed entry in the city for such purpose only. Their movement will be strictly monitored from the point of entry to the point of exit.

To enable the National Government and their attached agencies to fulfill their respective mandates, those considered as APOR by their respective agencies, government officials/personnel on official business shall be allowed to enter Tuguegarao City, provided that the following protocols are observed:

1. Present valid IDs issued by their respective government agencies;
2. Present original or certified true copy of travel authority/order issued by the Department. Secretary of his/her designated official;
3. Pass symptom screening upon arrival;
4. Prior to the arrival, they are required to submit their **ITINERARY** during their period of stay in the city through **Command Center Hotline 0916-887-2897**, **specifically providing the following information:**

- Nature of business;
- Place and Time of transaction;
- Name of the persons/clients they will transact with and their contact numbers;
- Vehicle to be used during their stay including plate number;
- Name of the driver with contact number

Section 10. Curfew Hours. There shall be a curfew from 9 o'clock in the evening to 5 o'clock in the morning in Tuguegarao City during the Enhanced Community Quarantine (ECQ). The following are hereby exempted:

- a. Health workers and hospital personnel;
- b. Authorized government officials and employees, like peace officers and elected government officials **in the performance of their duties**;
- c. Members of the Armed Forces of the Philippines, Philippine National Police Bureau of Fire Protection, and Bureau of Jail Management and Penology;
- d. Barangay Officials and Tanods **on duty**;
- e. Those persons involved in **emergency medical cases**;
- f. Those involved in providing **basic necessities** like food and medicine such as market vendors (wholesale or retail) including those coming from other areas outside Tuguegarao City ;
- g. Drivers and helpers of delivery trucks when loading and unloading of **fruits and vegetables and agricultural products e.g. live hogs, cattle, broilers, eggs and the like**;
- h. Funeral parlors **when retrieving/servicing of cadavers**;
- i. Priests and religious personnel administering religious rites at night;
- j. Street sweepers, garbage collectors, slaughter house workers **on night shift duty and meat delivery personnel**; and
- k. Those providing **basic medical necessities and delivery services for food and other basic necessities may operate 24/7.**

Section 11. Operation of Talipapas. Talipapas located in the different barangays of the City shall be allowed to operate daily during the duration of ECQ. All satellite markets shall operate on a daily basis, provided that minimum health protocols are observed at all times.

Ambulant vendors including street vendors shall not be allowed during the duration of ECQ.

Section 12. COVID Shield Control Pass. During the duration of the ECQ, the use of the COVID Shield Control Pass shall be strictly implemented except visitors pass.

In lieu of the visitors pass, Travel Pass issued by their respective LGU of Origin shall be presented.

Section 13. *Violations.* Any person violating any provisions of this Order shall be dealt with in accordance with pertinent provisions of law.

Section 14. *Enforcement / Implementation.* The Philippine National Police - Tuguegarao City, Public Safety and Security Office, Tricycle Regulation Unit, Market Administrator, Task Force Disiplina, Punong Barangays and Barangay Tanods in their respective jurisdictions shall ensure the strict observance of these guidelines.

Section 15. *Repealing Clause.* All prior issuances or parts thereof inconsistent with this Executive Order are hereby repealed, amended or otherwise modified accordingly, areas previously declared as Critical Zone (CrZ) and placed under Enhanced Community Quarantine (ECQ) shall remain under strict lockdown.

Section 16. *Effectivity.* This Executive Order shall take effect at 12:01 AM of March 30, 2021. The Enhanced Community Quarantine (ECQ) in Tuguegarao City shall be valid for ten (10) days, subject to extension based on the assessment conducted by the Tuguegarao City Task Force Against COVID-19 and concurrence of the Cagayan Valley Regional Inter-Agency Task Force.
