



EXECUTIVE ORDER NO. 56
Series of 2020

**"AN ORDER PROVIDING GUIDELINES IN THE OPERATION OF MOTORCYCLE
IN THE CITY TO FERRY/FETCH HOUSEHOLD MEMBERS FOR THE PERIOD OF
THE GENERAL COMMUNITY QUARANTINE"**

WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the *Local Government Code of 1991*, "states that the Local Government Units are authorized to exercise powers necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of general welfare:"

WHEREAS, President Rodrigo Roa Duterte issued Executive Order No. 112 dated April 30, 2020, imposing Enhanced Community Quarantine in High Risk Geographic Areas of the Philippines and a General Community Quarantine in the rest of the country from May 1 to May 15, 2020;

WHEREAS, based on the abovementioned Executive Order, Cagayan has been shifted from Enhanced Community Quarantine (ECQ) to General Community Quarantine (GCQ), wherein government agencies, establishments and public transportations are allowed to operate subject to limitations provided for in the guidelines set by the Inter Agency Task Force (IATF) for COVID-19 and of the policies coming from the Local Government Units;

WHEREAS, Executive Order 29, series of 2020 entitled: *An Order Banning Backriding on Motorcycles in Tuguegarao City* was issued last March 17, 2020, which provides guidelines to the operation of backriding on motorcycles in the city ;

WHEREAS, it is but proper to give exception to motorcycles operating in the city who will ferry or fetch household members notwithstanding the guidelines provided on the abovementioned Executive Order;

NOW, THEREFORE, I, **ATTY. JEFFERSON P. SORIANO**, City Mayor of Tuguegarao, by virtue of the powers vested in me by the Constitution and the laws, do hereby order the following:

Section 1. Operation of Motorcycles (Backriding). Backriding on motorcycles shall be allowed to ferry and fetch household members. A Barangay Certification must be secured certifying to the effect that the passenger is a member of the household of the driver.

Section 2. Violation. Any violation of the provisions of this Executive Order shall be dealt with in accordance with pertinent provisions of law.

Section 3. Enforcement / Implementation. This Order shall be implemented by the Tuguegarao City Police Force, Public Safety and Security Office, Punong Barangays and Barangay Tanods in their respective jurisdictions.

Section 4. *Repealing Clause.* All prior issuances or parts thereof inconsistent with this Executive Order are hereby repealed, amended or otherwise modified accordingly.

Section 5. *Effectivity.* This Order shall take effect immediately and shall subsist until the General Community Quarantine is lifted.
