## "AN ORDER PROVIDING GUIDELINES IN THE OPERATION OF TRICYCLE IN THE CITY TO FERRY/FETCH HOUSEHOLD MEMBERS FOR THE PERIOD OF THE GENERAL COMMUNITY QUARANTINE"

WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the *Local Government Code of 1991*, "states that the Local Government Units are authorized to exercise powers necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of general welfare;"

WHEREAS, President Rodrigo Roa Duterte issued Executive Order No. 112 dated April 30, 2020, imposing Enhanced Community Quarantine in High Risk Geographic Areas of the Philippines and a General Community Quarantine in the rest of the country from May 1 to May 15, 2020;

WHEREAS, based on the abovementioned Executive Order, Cagayan has been shifted from Enhanced Community Quarantine (ECQ) to General Community Quarantine (GCQ), wherein government agencies, establishments and public transportations are allowed to operate subject to limitations provided for in the guidelines set by the Inter Agency Task Force (IATF) for COVID-19 and of the policies coming from the Local Government Units;

WHEREAS, City Ordinance No. 19-08-2020 entitled: An Ordinance Regulating the Operation of Tricycles in the City within the Period of the General Community Quarantine (GCQ) and Suspending for the Meantime the Existing Fare Matrix of City Ordinance No. 21-2018, was issued last May 1, 2020, which provides guidelines to the operation of tricycle in the City which shall follow the body number-ending scheme on a calendar date-basis;

WHEREAS, it is but proper to give exception to tricycles operating in the city who will ferry or fetch household members for work purposes notwithstanding the guidelines provided on the abovementioned Ordinance;

NOW, THEREFORE, I, ATTY. JEFFERSON P. SORIANO, City Mayor of Tuguegarao, by virtue of the powers vested in me by the Constitution and the laws, do hereby order the following:

Section 1. Operation of Tricycle. In accordance with City Ordinance No. 19-08-2020, the operation of tricycle in the city shall follow the body number-ending scheme on a calendar date basis, to wit:

- a. Those ending in the number one (1), shall operate only on the calendar dates 1, 11, 21 and 31;
- b. Those ending in the number one (2), shall operate only on the calendar dates 2, 12 and 22;

- c. Those ending in the number one (3), shall operate only on the calendar dates 3, 13 and 23;
- d. Those ending in the number one (4), shall operate only on the calendar dates 4, 14 and 24;
- e. Those ending in the number one (5), shall operate only on the calendar dates 5, 15 and 25;
- f. Those ending in the number one (6), shall operate only on the calendar dates 6, 16 and 26;
- g. Those ending in the number one (7), shall operate only on the calendar dates 7, 17 and 27;
- h. Those ending in the number one (8), shall operate only on the calendar dates 8, 18 and 28;
- i. Those ending in the number one (9), shall operate only on the calendar dates 9, 19 and 29; and
- j. Those ending in the number one (0), shall operate only on the calendar dates 10, 20 and 30.

**Section 2.** *Exceptions*. Tricycles who will ferry or fetch household members in going to their respective offices or work establishments (work related only) shall be allowed to operate provided, a Barangay Certification has been issued certifying that the passenger is a member of the driver's household. Moreover, the passenger shall be required to present employment ID at checkpoints.

Provided further, that the duration for the said purpose shall be limited for one (1) hour only.

Provided finally, that the one-passenger per tricycle policy shall be strictly observed.

**Section 3.** *Violation.* In accordance with City Ordinance No. 19-08-2020, violation of this Order shall suffer the penalty of having the tricycle impounded for the entire duration of the GCQ.

**Section 4**. *Enforcement / Implementation*. This Order shall be implemented by the Tuguegarao City Police Force, Public Safety and Security Office, Punong Barangays and Barangay Tanods in their respective jurisdictions.

**Section 5.** *Repealing Clause.* All prior issuances or parts thereof inconsistent with this Executive Order are hereby repealed, amended or otherwise modified accordingly.

**Section 6.** *Effectivity*. This Order shall take effect immediately and shall subsist until the General Community Quarantine is lifted.
