## "AN ORDER MANDATING BUSINESS ESTABLISHMENTS TO BAN THE ENTRY OF CUSTOMERS WITHOUT COVID SHIELD CONTROL PASS"

WHEREAS, the prime duty of the government is to serve and protect the people, the maintenance of peace and order, the protection of life, liberty, and property, and the promotion of general welfare;

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the *Local Government Code of 1991*, states that Local Government Units are authorized to exercise powers necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of general welfare;

WHEREAS, in response to the growing concern over the outbreak of COVID-19, President Rodrigo R. Duterte through Proclamation No. 922, declared the Philippines under STATE OF PUBLIC HEALTH EMERGENCY;

WHEREAS, the Office of the President has placed Tuguegarao City under General Community Quarantine effective May 1, 2020;

WHEREAS, certain business establishments in Tuguegarao City are allowed to operate during General Community Quarantine;

WHEREAS, there is a need to limit or regulate the number of people going out of their residences to contain the spread of COVID 19;

WHEREAS, Tuguegarao City Government issued a protocol on population movement through City Ordinance No. 24-08-2020;

WHEREAS, it is imperative to mandate all business establishments in Tuguegarao City to ban the entry of customers without COVID Shield Control Pass to ensure strict compliance with the Ordinance;

NOW, THEREFORE, I, ATTY. JEFFERSON P. SORIANO, City Mayor of Tuguegarao City, Cagayan, by virtue of the powers vested in me by law, do hereby order the following:

Section 1. Scope and Application. This order shall apply to ALL BUSINESS ESTABLISHMENTS in Tuguegarao City which are allowed to operate during the General Community Quarantine (GCQ).

Section 2. "No COVID Shield Control Pass, No Entry" Policy. All business establishments in Tuguegarao City are mandated to require the presentation of any of the following COVID Shield Control Pass upon entry of customers:

- a. Frontliner's Pass;
- b. Visitor's Pass;
- c. Resident's Pass;
- d. Employer/Employee Pass;
- e. Vendor's Pass;

- f. Online Seller's Pass;
- g. Transient Pass;
- h. Medical Pass;
- i. Officiant's Pass;
- j. Kasambahay Pass; and
- k. Skilled Worker's Barangay Certification (for local farmers, fisherfolks, carpenters, or other skilled workers)

Those who fail to present the required ID should not be entertained/allowed entry in the establishment.

For government employees, office ID will suffice any time of the week.

**Section 3.** Compliance Monitoring. The Market Administrator, Business Permits and Licensing Office (BPLO) and the Philippine National Police (PNP) are hereby tasked to monitor compliance with this Order.

**Section 4.** *Repealing Clause.* All prior issuances or parts thereof inconsistent with this Executive Order are hereby repealed or amended accordingly.

Section 5. Effectivity. This Order shall take effect immediately.
