

EXECUTIVE ORDER NO. 62

Series of 2020

**“AN ORDER PROVIDING FOR THE FUNCTIONS OF BORDER CHECKPOINTS
IN TUGUEGARAO CITY DURING THE GENERAL COMMUNITY
QUARANTINE”**

WHEREAS, the latest guidelines from the IATF no longer require the issuance of a **TRAVEL PASS** for persons traveling within the province, and, that such **TRAVEL PASS** is only required when traveling from one province to another;

WHEREAS, by virtue of this development, the checkpoints of the City Government positioned at Barangay Carig Norte, Tuguegarao City, and at Maddarulug, Solana, will no longer be required to check the **TRAVEL PASS** of incoming and outgoing persons within the province;

NOW, THEREFORE, premises considered, I, **ATTY. JEFFERSON P. SORIANO**, City Mayor of Tuguegarao City, by virtue of the powers vested in me by the Constitution and the laws, do hereby order the following:

Section 1. Functions of the Established Checkpoints. The established checkpoints shall have the following functions:

1. The checkpoints at Carig Norte, Tuguegarao City, and Maddarulug, Solana, shall still be maintained but exclusively manned by Police Officers of the Tuguegarao City Police Station;
2. That said checkpoints shall no longer check nor require **TRAVEL PASS** from persons going in and out of Tuguegarao City except those coming from other provinces entering Tuguegarao City;
3. That the main function of these checkpoints shall be as follows:
 - a. to require all closed vehicles to open their windows to check on the compliance of passengers to the “**social distancing**” requirement;
 - b. to verify that no vehicle has a passengers who is either a minor (20 years old and below), a senior citizen (60 years old and above), pregnant woman, lactating woman, or a sick person (except when such sick person is being brought for treatment in a hospital or a private doctor or returning home from treatment);
 - c. for passenger utility vans (PUVs), to verify the **SPECIAL PERMIT** to operate issued by the Land Transportation Franchising and Regulatory Board (LTFRB), Regional Office No. 02;
 - d. to check that PUVs comply with the 50% passenger load capacity for social distancing purposes;

- e. to check that PUVs do not transport minors, senior citizens, pregnant women, lactating women, and sick persons (unless being brought for treatment or returning home from treatment).

Section 2. Repealing Clause. All prior issuances or parts thereof inconsistent with this Executive Order are hereby repealed, amended or otherwise modified accordingly.

Section 3. Effectivity. This Order shall take effect on June 1, 2020 and shall remain so until the end _____ of the General Community Quarantine.
