EXECUTIVE ORDER NO. 74

Series of 2020

"AN ORDER PLACING BARANGAY CATAGGAMAN VIEJO UNDER TOTAL LOCKDOWN FOR TEN (10) DAYS"

WHEREAS, after the declaration of the 2019 Corona Virus Disease or the COVID-19 as a pandemic by the World Health Organization, the number of confirmed cases throughout the country has increased alarmingly;

WHEREAS, the Office of the President, through Executive Order No. 112 Series of 2020, authorizes Mayors of Cities and Municipalities to impose, lift or extend Enhanced Community Quarantine in barangays, upon the concurrence of the relevant regional counterpart body of the IATF;

WHEREAS, Tuguegarao City has recorded four (4) Confirmed Cases of COVID-19 at Atal Street, Barangay Cataggaman Viejo, this City;

WHEREAS, as per Inter-Agency Task Force on COVID – 19 Guidelines, the presence of at least two (2) positive cases in a barangay requires total lockdown of the affected barangay;

WHEREAS, Executive Order No. 72 Series of 2020 entitled "An Order Adopting Zoning Containment Strategy in Barangay Cataggaman Viejo, Tuguegarao City, Cagayan" was issued on August 17, 2020 placing portions of Barangay Cataggaman Viejo under Zonal Containment, was adopted to contain local transmission;

WHEREAS, due to the alarming spread of COVID-19 in Barangay Cataggaman Viejo and in nearby areas, and, as a matter of fact has possibly spread up to Barangays Cataggaman Pardo and Ugac Norte, this City, there is a need that the whole Barangay Cataggaman Viejo be placed under Total Lockdown for ten (10) days, from August 21-31, 2020, to contain the spread of the virus;

NOW, THEREFORE, I, ATTY. JEFFERSON P. SORIANO, by virtue of the powers vested in me by law as Mayor of Tuguegarao City, Cagayan, do hereby order the following:

Section 1. *TOTAL LOCKDOWN*. Barangay Cataggaman Viejo, Tuguegarao City is hereby placed under total lockdown for ten (10) days. Entrance and exit therefrom of all individuals whether a resident or not, shall be strictly prohibited beginning 1 o'clock in the afternoon of August 21, 2020.

All residents are hereby ordered to stay inside their respective residences and submit and duly comply with all rules and regulations pertaining to the total lockdown.

Section 2. *Community Curfew*. Curfew from 6 o'clock in the evening to 6 o'clock in the morning is hereby imposed within Barangay Cataggaman Viejo. All business establishments within the barangay are prohibited to operate during the curfew hours.

Section 3. *Exemptions*. Only emergency cases which require immediate medical and hospital attention as determined by the proper health authorities are exempted from this Order.

Physicians, nurses and other health workers residing in the area are allowed to exit, however, they will no longer be allowed to enter the area during the duration of the lockdown.

Section 4. *Violation.* Any person violating this Order shall be dealt with in accordance with pertinent provisions of law.

Section 5. *Enforcement / Implementation*. This Order shall be implemented by the Barangay Officials of Cataggaman Viejo, Philippine National Police, and Public Safety and Security Office, City Health Office, City General Services Office.

Barangay Officials of Cataggaman Nuevo and Barangay Cataggaman Pardo shall assist in the implementation and enforcement of this Executive Order.

Section 6. Operational Plan. An Operational Plan attached hereto as Annex "A", shall govern the movements and activities within Cataggaman Viejo during the ten (10) day lockdown.

Section 7. *Repealing Clause.* All prior issuances or parts thereof inconsistent with this Executive Order are hereby repealed, amended or otherwise modified accordingly.

Section 8. *Effectivity*. This Order shall take effect at 1 o'clock in the afternoon of August 21, 2020.

DATE : 21 AUGUST 2020

I. SITUATION:

World Health Organization recently declared Corona Virus Disease 2019 (COVID-19) as pandemic. PPRD after consultation with the Inter-Agency Task Force (IATF) in connection with the increasing cases of COVID-19 in Metro-Manila, placed the entire National Capital Region (NCR) under community quarantine and considering that COVID-19 have spilled into the neighboring provinces outside Metro-Manila, he again declared the entire Luzon Island under Enhanced Community Quarantine, and subsequently declared the whole country under state of calamity.

As of 21 August 2020, Tuguegarao City registered seven (8) positive patients with COVID-19, four (4) of whom are from Barangay Cataggaman Viejo and four (4) from Barangay Ugac Norte.

LOCKDOWN is defined as – an emergency measure or condition in which people are temporarily prevented from entering or leaving a restricted area during a threat or danger.

II. MISSION:

To place Barangay Cataggaman Viejo under Zoning Containment Strategy. Period of the activity: August 21-31, 2020.

III. CONCEPT OF EXECUTION:

A. MITIGATION.

- 1. To close all street entrances and exits within the boundaries of Barangay Cataggaman Viejo particularly along Maramag St., Atal St., Andal St. and Lagundi St. all starting at Provincial Road considering that House No. 29 along Atal St. residence of confirmed positive COvid-19 patients, and House No. 42 along Pasicolan St. residence of suspected Covid-19 patient awaiting laboratory results are classified as Critical Zone and shall be placed under Enhanced Community Quarantine.
- 2. Strictly confine the movement of all residents and prevent anyone from entering the abovementioned contained zone.
- 3. An Incident Command Post (ICP)/Barangay Operations Center (BOC) for this purpose shall be established at the corner of Provincial Road (PR) and Atal Street, and seven (7) primary and secondary checkpoints shall be established at PR corner Maramag St., PR corner Andal St., PR corner Lagundi St., corner Maramag- Addatu Sts., Maramag- Cabauatan Sts.; end of Maramag St. to Cagayan River Control and Lagundi St. to quarrying areas.
- 4. All established checkpoints shall be manned with manpower complement of one (1) PNP, one (1) from POSU, one (1) Barangay Tanod, one (1) barangay official on a 24/7 duty status.

B. SUPPRESSION.

- 1. Barangay Cataggaman Viejo shall be placed under twelve (12) hours curfew from 6:00 pm to 6:00 am for the entire duration of the zonal containment.
- 2. Residents are only allowed to go out of their residences for essential errands within the barangay.

C. TASKS.

1. PUNONG BARANGAY/ KAGAWAD

- Head of the BOC and the Incident Commander (IC) of the Incident Command Post (ICP) to be established in the barangay;
- Ensure the strict compliance of all the provisions of the zonal containment;
- Shall have the operational supervision and control of all checkpoints in the barangay;
- d. Provide additional manpower support in all these checkpoints;
- e. Mobilize all barangay officials;
- f. Establish and organize flea market in the contained area particularly beside the ICP at the corner of PR and Atal St. in coordination with the City Market Administrator;

- g. Ensure that health protocols shall be strictly observed in the flea market;
- h. Barangay officials of adjacent barangays must provide manpower support in the designated checkpoints within their territorials boundaries; and
- i. Perform other tasks as directed by the City Mayor.

2. CHIEF OF POLICE - TCPS

- a. Provide uniformed personnel in support of the implementation of this zonal containment especially in checkpoints;
- b. Conduct 24 hour mobile patrol; and
- c. Perform other tasks as directed by the City Mayor.

3. CHIEF OF POSU

- a. Provide traffic and control management in the area;
- b. Augment the PNP personnel assigned in the checkpoints; and
- c. Perform other tasks as directed by the City Mayor.

4. CITY HEALTH OFFICER

- a. Strictly monitor the health conditions of the traced contacts of confirmed COVID-19 patients;
- b. Continue regular contact tracing as necessary;
- c. Regularly report to the City Mayor and PB re these monitoring and contact tracing; and
- d. Perform other tasks as directed by the City Mayor.

5. CITY GENERAL SERVICES OFFICER (CGSO)

- a. Provide logistical support; and
- b. Perform other tasks as directed by the City Mayor.

6. CHECK POINT COMMANDER (CPC)

- a. Ensure that no resident of the abovementioned areas will be allowed to leave the contained area and no person is allowed entry unless cleared either by the CHO, City Administrator and the City Mayor;
- b. Have direct control over all checkpoints in the area;
- c. Coordinate continuously with the PB pertaining to the daily activity of the checkpoints; and
- d. Perform other tasks as directed by the City Mayor.

7. CITY BUDGET OFFICER

- a. Release appropriate funds to support the zoning containment; and
- b. Perform other tasks as directed by the City Mayor.

8. CITY DRRM OFFICE

a. Conduct regular disinfection activities in the abovementioned contained zone;

- b. Conduct inventory of indigent families for the preparation of relief assistance upon certification of the PB; and
- c. Perform other tasks as directed by the City Mayor.

9. CITY INFORMATION OFFICE

- a. Provide documentary records of the daily activities in the contained area and submit same to the Office of the City Mayor; and
- b. Perform other tasks as directed by the City Mayor.

IV. ADMINISTRATION

1. The Assistant City Administrator shall be designated as the Responsible Official in the implementation of this operational plan and all concerns and queries must be coursed thru CP No.: 0975-969-6172 or 0905-225-1118.

V. COORDINATING INSTRUCTIONS

- 1. The entire barangay is under strict liquor ban.
- 2. Gambling activities are not allowed.
- 3. Only direct relatives are allowed during wakes.
- 4. Only medical/health frontliners are allowed to leave the abovementioned areas. Other residents shall be allowed to leave the said areas upon approval of any of the following: 1.) City Health Officer, 2.) City Administrator and 3.) City Mayor.
- 5. All existing health protocols and issuances must be strictly observed.
- 6. Lateral coordination is hereby enjoined.

VI. EFFECTIVITY

Effective 1300H 21 August 2020.
