## **EXECUTIVE ORDER NO. 75**

Series of 2020

## "AN ORDER ADOPTING ZONING CONTAINMENT STRATEGY FOR ZONE 6 and ZONE 7, LIBAG SUR, TUGUEGARAO CITY, CAGAYAN"

WHEREAS, after the declaration of the 2019 Corona Virus Disease of the COVID-19 as a pandemic by the World Health Organization (WHO), the number of confirmed cases throughout the country increased alarmingly;

WHEREAS, Tuguegarao City has recorded one (1) confirmed case of COVID-19 at Zone 6 and Zone 7 of Barangay Libag Sur, Tuguegarao City, Cagayan;

WHEREAS, the Office of the President, through Executive Order No. 112 Series of 2020, authorizes Mayors of Cities and Municipalities to impose, lift or extend Enhanced Community Quarantine in barangays, upon the concurrence of the relevant regional counterpart body of the IATF;

WHEREAS, the National Task Force COVID-19 issued Memorandum Circular No. 02, Series of 2020 providing Operational Guidelines on the Application of the Zoning Containment Strategy in the Localization of the National Action Plan against COVID-19 response;

WHEREAS, Section 6.2 of the said NTF COVID-19 Memorandum provides that LGUs shall be categorized into four (4) zoning classifications, namely, Critical Zone (CrZ0, Containment Zone (CZ), Buffer Zone (BZ) and Areas Outside Buffer Zone (OBZ);

WHEREAS, based on Memorandum and assessment made by the City Task Force against COVID-19 of Tuguegarao City, zoning containment strategy at Zone 6 and Zone 7 of Barangay Libag Sur has to be adopted in order to effectively contain local transmission of the COVID-19;


WHEREAS, there was a report that the PNP Personnel who was confirmed positive for COVID-19 in the said area mingled with several persons after he had undergone swab test and the City Contact Tracing Team is still in the process of completing the contact tracing of all possible individuals he may have contact with;

**NOW, THEREFORE, I, ATTY. JEFFERSON P. SORIANO,** City Mayor of Tuguegarao, by virtue of the powers vested in me by the Constitution and the laws, do hereby order the following:

Section 1. ZONING CONTAINMENT CLASSIFICATION. Zone 6 and Zone 7 of Barangay Libag Sur of this City is hereby classified as CRITICAL ZONE (CrZ) and is hereby placed under ENHANCED COMMUNITY QUARANTINE.

All entrance and exit points surrounding of Zone 6 and Zone 7 of Barangay Libag Sur shall be barricaded to avoid ingress and egress of residents therein.

Section 2. PROTOCOLS AND MINIMUM PUBLIC HEALTH STANDARDS. All community quarantine protocols and minimum public health standards set forth under the Omnibus Guidelines on the implementation of Community Quarantine in the Philippines issued by the IATF, relevant rules and regulations issued by concerned National Government Agencies, and local ordinances and policies issued by the City for the classification of Enhanced Community Quarantine as stated above are hereby enforced.

**Section 3.** *REPEALING CLAUSE.* All orders and similar issuances or parts thereof inconsistent with this Executive Order are hereby repealed and amended accordingly.

**Section 4.** *EFFECTIVITY*. This Executive Order shall take effect upon the concurrence of the Regional Inter-Agency Task Force against COVID-19.

The hereby adopted zoning containment classification and the corresponding type of community quarantine shall be valid for fourteen (14) days, subject to extension based on the reassessment and re-categorization conducted by the City Task Force against COVID-19.
