EXECUTIVE ORDER NO. <u>84</u> Series of 2020

"AN ORDER LIFTING THE ZONING CONTAINMENT STRATEGY FOR ZONE 6 AND 7, BARANGAY LIBAG SUR, TUGUEGARAO CITY, CAGAYAN"

WHEREAS, the Office of the President, through Executive Order No. 112 Series of 2020, authorizes Mayors of Cities and Municipalities to impose, lift or extend Enhanced Community Quarantine in barangays, upon the concurrence of the relevant regional counterpart body of the IATF;

WHEREAS, Executive Order No. 75 Series of 2020 entitled, "AN ORDER ADOPTING ZONING CONTAINMENT STRATEGY FOR ZONE 6 AND 7, LIBAG SUR, TUGUEGARAO CITY, CAGAYAN," was issued on August 24, 2020 to arrest the spread of the virus;

WHEREAS, the Cagayan Valley Regional Inter-Agency Task Force (CVRIATF) issued RIATF Resolution No. 58 Series of 2020 concurring Executive Order No. 75 Series of 2020 modified its imposition from August 25 – 30, 2020 and extendible for another five days if warranted;

WHEREAS, on August 30, 2020, the imposition of Enhanced Community Quarantine on Zone 6 and 7 of Barangay Libag Sur was extended for another five (5) days pending the completion of contact tracing of primary contacts of the PNP Personnel who was confirmed positive;

WHEREAS, Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID) National Task Force COVID-19 Memorandum Circular No. 2, series of 2020 provides that, 'lifting of a community quarantine imposed upon a geographical unit shall be done when all surveillance, testing and quarantine/isolation intervention/activities have been completed';

WHEREAS, all suspected cases at Zone 6 and 7 of Barangay Libag Sur, Tuguegarao City, have already tested negative and no new suspect, probable or confirmed case was identified after the completion of the zoning containment in the said area;

NOW, THEREFORE, I, ATTY. JEFFERSON P. SORIANO, by virtue of the powers vested in me by law as Mayor of Tuguegarao City, Cagayan, do hereby order the following:

Section 1. Lifting of Total Lockdown. The Zoning Containment Strategy for Zone 6 and 7 of Barangay Libag Sur, Tuguegarao City is hereby lifted effective 1 o'clock in the afternoon of September 04, 2020.

All residents are hereby directed to abide by the existing regulations imposed in Tuguegarao City under the current quarantine status of the City.

Section 2. *Repealing Clause.* All prior issuances or parts thereof inconsistent with this Executive Order are hereby repealed, amended or otherwise modified accordingly.

Section 3. *Effectivity***.** This Order shall take effect at 1 o'clock in the afternoon of September 04, 2020.
