EXECUTIVE ORDER NO. 88
Series of 2020

**“AN ORDER REGULATING THE OPERATIONS OF ‘TALIPAPAS’ IN
TUGUEGARAO CITY”**

WHEREAS, under Section 15, Article II of the 1987 Philippine Constitution it is the State’s Policy to protect and promote the right to health of the people;

WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the *Local Government Code of 1991*, “states that the Local Government Units are authorized to exercise powers necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of general welfare;”

WHEREAS, the World Health Organization has declared Corona Virus Disease (COVID - 19) as a pandemic and in response thereto, President Rodrigo R. Duterte through Proclamation No. 922, declared the Philippines under State of Public Health Emergency;

WHEREAS, Executive Order No. 85 Series of 2020 entitled ‘**AN ORDER REVERTING TUGUEGARAO CITY TO MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ) STATUS**’ was issued on September 4, 2020;

WHEREAS, Section 4 of Executive Order No. 85 Series of 2020 regulated the operations of ‘*talipapas*’ in the City to Fridays, Saturdays and Sundays only;

WHEREAS, there is a need to revise the scheduled operation of ‘*talipapas*’ in Tuguegarao City to control the movement of residents in the City and to give opportunity for the operation of the program of the Department of Trade and Industry called “Dafun Uffun ta Magaru”;

NOW, THEREFORE, I, ATTY. JEFFERSON P. SORIANO, City Mayor of Tuguegarao, by virtue of the powers vested in me by the Constitution and the laws, do hereby order the following:

Section 1. Operation of ‘Talipapas’. All existing ‘*talipapas*’ are hereby ordered to operate from Mondays to Thursdays only;

Section 2. Operation of Dafun. ‘*Dafun Uffun para ta Magaru*’ of the Department of Trade and Industry (DTI) shall operate on strategic locations in the City on Fridays, Saturdays and Sundays;

Section 3. Violation. Any person or establishment violating the provisions of this Order shall be dealt with in accordance with pertinent laws.

Section 5. Enforcement / Implementation. This Order shall be implemented by the Office of the Market Administrator, Philippine National Police, Public Safety and Security Office and the Barangay Officials and Tanods of the different barangays.

Section 6. Repealing Clause. All prior issuances or parts thereof inconsistent with this Executive Order are hereby repealed, amended or otherwise modified accordingly.

Section 4. Effectivity. This Order shall take effect immediately shall remain so until this order shall be amended or repealed.
