



**EXECUTIVE ORDER NO. 96**  
Series of 2020

**“AN ORDER ADOPTING ZONING CONTAINMENT STRATEGY AT  
ZONE 2, BARANGAY TANZA, TUGUEGARAO CITY, CAGAYAN  
FOR TEN (10) DAYS”**

**WHEREAS**, after the declaration of the 2019 Corona Virus Disease or the COVID-19 as a pandemic by the World Health Organization, the number of confirmed cases throughout the country has increased alarmingly;

**WHEREAS**, the Office of the President, through Executive Order No. 112 Series of 2020, authorizes Mayors of Cities and Municipalities to impose, lift or extend Enhanced Community Quarantine in barangays, upon the concurrence of the relevant regional counterpart body of the IATF;

**WHEREAS**, the National Task Force on COVID-19 issued Memorandum Circular No. 02, s 2020 providing Operational Guidelines on the Application of the Zoning Containment Strategy in the Localization of the National Action Plan against COVID-19 response;

**WHEREAS**, Tuguegarao City has recorded one (1) Confirmed Case of COVID-19 at Zone 2 of Barangay Tanza, Tuguegarao City;

**WHEREAS**, Section 6.2 of the said NTF COVID-19 Memorandum provides that LGUs shall be categorized into four (4) zoning classifications, namely. Critical Zone (CrZ), Containment Zone (CZ), Buffer Zone (BZ) and Areas Outside Buffer Zone (OBZ);

**WHEREAS**, the Tuguegarao City Inter-Agency Task Force Against COVID-19 during the TCIATF meeting held on September 21, 2020, suggested that a total lockdown of Zone 2 in Barangay Tanza shall be in place to arrest the spread of COVID-19;

**WHEREAS**, based on the assessment made by the Tuguegarao City Task Force against COVID-19, zoning containment strategy at Zone 2 of in Barangay Tanza has to be adopted in order to effectively contain the local transmission of COVID-19 and to complete the contact tracing of individuals with possible contact with the said confirmed case;

**NOW, THEREFORE, I, BIENVENIDO C. DE GUZMAN II**, by virtue of the powers vested in me by law as Acting City Mayor of Tuguegarao City, Cagayan, do hereby order the following:

**Section 1. ZONING CONTAINMENT CLASSIFICATION.** The entire Zone 2 (Macapagal Avenue corner Sarguelas Street, Sarguelas Street corner Romero Street and Sarguelas Street going to Parking Area of Zone 02), Barangay Tanza of this City is hereby classified as CRITICAL ZONE (CrZ) and is hereby placed under ENHANCED COMMUNITY QUARANTINE (ECQ).

All residents are hereby ordered to stay put at their respective residences and comply with all rules and regulations pertaining to the total lockdown.

All entrance and exit points of Zone 2 in Barangay Tanza shall be barricaded to prevent ingress and egress therein.

**Section 2. *Protocols and Minimum Public Health Standards.*** All community quarantine protocols and minimum public health standards set forth under the Omnibus Guidelines on the implementation of the Community Quarantine issued by the IATF, relevant rules and regulations issued by the City for the classification of ECQ are hereby enforced.

**Section 3. *Community Curfew.*** Curfew from 6 o'clock in the evening to 6 o'clock in the morning is hereby imposed within the said street. All business establishments within the barangay are prohibited to operate during the curfew hours.

**Section 4. *Exemptions.*** Only emergency cases which require immediate medical and hospital attention as determined by the proper health authorities are exempted from this Order.

Physicians, nurses and other health workers residing in the area are allowed to exit, however, they will no longer be allowed to enter the area during the duration of the Enhanced Community Quarantine (ECQ).

**Section 5. *Violation.*** Any person violating this Order shall be dealt with in accordance with pertinent provisions of law.

**Section 6. *Enforcement/ Implementation.*** This Order shall be implemented by the Barangay Officials of Barangay Tanza, Philippine National Police, and Public Safety and Security Office, City Health Office, City General Services Office.

**Section 7. *Operational Plan.*** An Operational Plan attached hereto as Annex "A", shall govern the movements and activities within Zone 2 in Barangay Tanza during the ten (10) day lockdown.

**Section 8. *Repealing Clause.*** All orders and similar issuances or parts thereof inconsistent with this Executive Order are hereby repealed and amended accordingly.

**Section 9. *Effectivity.*** This Executive Order shall take effect on the 21<sup>st</sup> day of September 2020.

The hereby adopted zoning containment classification and the corresponding type of community quarantine shall be valid for ten (10) days, subject to extension based on the assessment and re-categorization conducted by the City Task Force against COVID-19.

**DATE :** 21 SEPTEMBER 2020

**I. SITUATION :**

World Health Organization recently declared Corona Virus Disease 2019 (COVID-19) as pandemic. PPRD after consultation with the Inter-Agency Task Force (IATF) in connection with the increasing cases of COVID-19 in Metro-Manila, placed the entire National Capital Region (NCR) under community quarantine and considering that COVID-19 have spilled into the neighboring provinces outside Metro-Manila, he again declared the entire Luzon Island under Enhanced Community Quarantine, and subsequently declared the whole country under state of calamity.

As of today, 21 September 2020, Tuguegarao City registered one (1) positive patient with COVID-19, at Zone 02, Tanza, Tuguegarao City.

**II. MISSION :**

To place Zone 02 of Barangay Tanza under Zoning Containment from September 21- October 01, 2020.

**III. CONCEPT OF EXECUTION :**

**A. MITIGATION.**

**CHARACTER FIRST***Tuguegarao City!*

*"Napafutu nga Serbisyu para ta Pammacapianan na Magaru"*



1. To close all entrances and exits from Macapagal Avenue corner Sarguelas Street, Sarguelas Street corner Romero Street and Sarguelas Street going to Parking Area of Zone 02, Barangay Tanza where the residence of the confirmed positive Covid-19 patient is situated and shall be under strict enhance community quarantine.
2. Strictly confine the movement of all residents within the abovementioned contained zone.
3. To prevent anyone from entering the abovementioned critical zone areas.
4. An Incident Command Post (ICP)/Barangay Operations Center (BOC) for this purpose shall be established at the Barangay Hall and three (3) control points with manpower complement of two (2) PNP, two (2) Barangay Tanod/official and two (2) TMG-POSU at Macapagal Avenue cor. Sarguelas Street, Sarguelas Street cor. Romero Street and Sarguelas Street going to Parking Area of Zone 02, Barangay Tanza.

#### **B. SUPPRESSION.**

1. The abovementioned Critical Zone Area shall be placed under curfew from 6:00 pm to 6:00 am for the entire duration of the zonal containment.
2. Conduct 24 hour mobile patrol.
3. Residents are only allowed to go out of their residences for essential errands in the designated barangay flea market (talipapa) which shall be established beside the BOC.

#### **C. TASKS.**

##### **1. PUNONG BARANGAY/KAGAWAD**

- a. Head of the BOC and the Incident Commander (IC) of the Incident Command Post (ICP) to be established in the barangay;
- b. Ensure the strict compliance of all the provisions of the zonal containment;
- c. Shall have the operational supervision and control of all checkpoints in the barangay;
- d. Provide additional manpower support in all these checkpoints;
- e. Mobilize all barangay officials;
- f. Ensure that health protocols shall be strictly observed in the flea market;
- g. Establish and organize flea market in the contained area particularly beside the BOC in coordination with the City Market Administrator;
- h. Perform other tasks as directed by the City Mayor.

##### **2. CHIEF OF POLICE - TCPS**



- a. Provide uniformed personnel in support of the implementation of this zonal containment especially in the command post and at the control point; and
- b. Perform other tasks as directed by the City Mayor.

### **3. CHIEF OF POSU**

- a. Provide traffic and control management in the area;
- b. Augment the PNP personnel assigned in the checkpoints; and
- c. Perform other tasks as directed by the City Mayor.

### **4. CITY HEALTH OFFICER**

- a. Strictly monitor the health conditions of the traced contacts of confirmed COVID-19 patients;
- b. Continue regular contact tracing as necessary;
- c. Regularly report to the City Mayor and PB re these monitoring and contact tracing; and
- d. Perform other tasks as directed by the City Mayor.

### **5. CITY GENERAL SERVICES OFFICER (CGSO)**

- a. Provide logistical support, three (3) thermal scanners, sanitizers/alcohol and put up three (3) tents at the BOC and at the control point with tables and chairs;
- b. Perform other tasks as directed by the City Mayor.

### **6. CHECK POINT COMMANDER (CPC)**

- a. Ensure that no resident of the abovementioned areas will be allowed to leave the lockdown area and no person is allowed entry unless cleared either by the CHO, City Administrator and the City Mayor;
- b. Have direct control over all control points in the area;
- c. Coordinate continuously with the PB pertaining to the daily activity of the checkpoints; and
- d. Perform other tasks as directed by the City Mayor.

### **7. CITY BUDGET OFFICER**

- a. Release appropriate funds to support the lockdown; and
- b. Perform other tasks as directed by the City Mayor.

### **8. CITY DRRM OFFICE**

- a. Conduct regular disinfection activities in the abovementioned contained zone; and
- b. Perform other tasks as directed by the City Mayor.

### **9. CITY INFORMATION OFFICE**

- a. Provide documentary records of the daily activities and submit same to the Office of the City Mayor; and
- b. Perform other tasks as directed by the City Mayor.



#### IV. ADMINISTRATION

1. The Assistant City Administrator shall be designated as the Responsible Official in the implementation of this operational plan and all concerns and queries must be coursed thru CP No.: 0975-969-6172 or 0905-225-6118.

#### V. COORDINATING INSTRUCTIONS

1. The entire barangay is under strict liquor ban.
2. Gambling activities are not allowed.
3. Only direct relatives are allowed during wakes.
4. **Only medical/health frontliners are allowed to leave the abovementioned areas. Other residents shall be allowed to leave the said areas upon approval of any of the following: 1.) City Health Officer, 2.) City Administrator and 3.) City Mayor.**
5. All existing health protocols and issuances must be strictly observed.
6. Lateral coordination is hereby enjoined.

#### VI. EFFECTIVITY
